## Memorandum:-

Government of India has given vide his Environment & Forest & Ministry Letter No. 6-GJB-97/2012-BHO/1093 dtd. 02.06.2014 refer above at (1) "In Principle" approval for Diversion of 2.115 Ha. Protected Forest land for of parallel/crossing in favour of Vodafone Idea Ltd. in Bhavanagr Dist. in Gujarat.

Vodafone Idea Ltd., Ahmedabad as reported that it has deposited an amount of Rs. 10,100/- (Rupees Ten thousand One hundred only) towards the cost of Registration fees, Processing fees is deposited in the account of 8782 Forest remittance(Deposit Head) on dtd. 15.07.2019.

The undersigned is please to convey the formal approval of the Government under Section-2 of the Forest (Conservation) Act. 1980 subject to following conditions.

- 1) The permission granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2) The forest land shall not be used for any purpose other than that specified in the FCA proposal.

- 3) The user Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- 4) The user Agency will have to make good the forest land after use / maintenance work. **No tree shall be cut.**
- 5) The User Agency will be liable to make good any loss to Forests / Environment caused due to the use of the said land by the user agency.
- 6) The User Agency will seek permission from the Roads & Buildings Department / Science and Technology Department. Sachivalaya, Gandhinagar.
- 7) The Gas pipeline will be laid underground in a trench depth of 2 mtr. and width of 0.90 mtr. in between rows of road side plantation.
- 8) Any other condition which the Nodal Officer (FCA) may stipulate from time to time.
