Feeder Main passing across the Forest College Campus, Coimbatore - 641002 for and on behalf of Coimbatore City Municipal Corporation, hereby undertake: -

1. That to pay additional amount of Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India.
2. That to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.


