I, am directed to invite your attention to the reference 3<sup>rd</sup> cited, in which the Government of India, Ministry of Environment and Forestry, have accorded approval in-principle (Stage-I) U/s 2 of Forest (C) Act, 1980, for diversion of forest land to and extent of **4.702** ha in Kothagudem, Khammam & Sathupally divisions under Khammam District - for laying of Pipe line and Construction of Structures in **Segment 26/2 [Wyra-Sathupalli (Part)]** for providing safe drinking water under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam, subject to fulfillment of certain conditions as stipulated therein.

2. I am to inform that the Government of India vide letter dt.17.04.2017 has conveyed Central Government **in-principle (Stage.I) approval** under Section 2 of Forest (Conservation) Act, 1980, for diversion of forest land to and extent of **4.702** ha in Kothagudem, Khammam & Sathupally divisions under Khammam District - for laying of Pipe line and Construction of Structures in **Segment 26/2 [Wyra-Sathupalli (Part)]** for providing safe drinking water under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam.

3. I am further to inform that the in-principle (*Stage.I*) approval have been communicated to all the concerned officers with instructions to submit condition-wise compliance report in the matter, vide PCCF, letter dt.27.04.2017.

4. I am also to inform that the District Forest Officers, Khammam and Bhadradri-Kothagudem Khammam has obtain compliance of conditions from the User Agency and submitted the condition-wise compliance report together with its enclosures through respective Conservators of Forests i.e., Khammam and Kothagudem respectively, which is received vide letters dt.13.06.2019 & 29.06.2019.
