Madhya Pradesh Urban Development & Housing Department is implementing the metro rail project in the cities of Bhopal and Indore. In Indore, 30.178 ha of forest land has been identified and transferred for the purpose of depot vide proposal no. FP/MP/OTHERS/33647/2018.

In this regards, stage 1 (in principle) approval has already been obtained. The relevant documents of mutation and respective KML file has been uploaded for stage 2 application. As per the conditions of the letter in the reference above the following list of compliances is being submitted for your consideration.


