Sub:- F(C) Act, 1980 – Diversion of 13.9887 ha (Nirmal – 9.7887 ha and Echoda – 4.20 ha (revised from 8.0972 ha)) of Forest land for Erection of 220kV DC Line from 400/200 KV SS Nirmal to the proposed 220/132KV SS Utnoor in Nirmal District under Thermal Power Transmission Scheme for Evacuation of power from 4 x 270 MW units at Nirmal and the above line route is passing through the forest in favour of Superintending Engineer, OMC Circle, TS TRANSCO, Adilabad – Submitted - Regarding.

I, am directed to invite your attention to the reference 3rd cited and to inform that the Government of India, Ministry of Environment, Forests & Climate Change, (RO), Chennai have accorded approval in-principle (Stage-I) U/s 2 of Forest (C) Act, 1980, for diversion of **13.9887 ha** (Nirmal 9.7887 ha and Echoda 4.20 ha (revised from 8.0972 ha)) of Forest land for Erection of 220kV DC Line from 400/200 KV SS Nirmal to the proposed 220/132KV SS Utnoor in Nirmal District under Thermal Power Transmission Scheme for Evacuation of power from 4 x 270 MW units at Nirmal in favour of Superintending Engineer, OMC Circle, TS TRANSCO, Adilabad, subject to fulfillment of certain conditions as stipulated therein.

2. I am to further information the Principal Chief Conservator of Forests (HoFF), Telangana State, in her letter 5th cited, has submitted condition wise compliance report on the conditions stipulated in in-principle (Stage-I) approval. The details of which are as follows:-

The User Agency has deposited an amount of Rs.95,00,326/- towards cost of Net Present Value which is a part of total amount of Rs. 4,18,58,370/- deposited through RTGS vide UTR No. SBINR52020060200130467 on Dt: 02.06.2020 into the Adhoc Telangana CAMPA account by generating the challan in the ministry's portal. (x)	The User Agency shall restrict the felling of trees to the minimum in the diverted width of 35 meters of the forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department;	The User Agency has paid an amount of Rs.52,000/- towards Extraction of Tree Growth which is a part of total amount of Rs. 2,74,000/- on Dt: 02.06.2020 into the Account of FDO, Echoda. (xii)	The User Agency at its cost shall provide bird deflectors, which are to be fixed on the upper conductor of the transmission line at suitable intervals to avoid bird hits;	Complied and undertaking given by the User Agency is enclosed.
(xiii)	The User Agency shall comply with the guidelines issued by the Ministry for laying transmission lines through forest areas;	Complied and undertaking given by the User Agency is enclosed.

(xix)	Disturbance shall be kept minimal by creating labour camps outside the forest area as far as possible and it will be the responsibility of the User Agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna. (xx)	The trees on strips would have to be felled but after shinging work is completed, natural regeneration will be allowed to come up. Future pollarding/pruning of trees will be done with the permission of the local Forest Officer, wherever necessary for the maintenance of the transmission lines. (xxvii)	In the event of failure to comply with any of the above conditions the User Agency is liable for penal action provision under FCA, 1980 and guidelines made there under.	Complied and undertaking given by the User Agency is enclosed.

3. I am to further inform that the User Agency has published the Stage-I forest clearance granted in verbatim along with the conditions and safe-guards imposed by the Central government in two widely circulated daily newspapers one in vernacular language and the other in English on 14.05.2020. Further, as per the request of the User Agency vide SE, OMC Circle, TSTRANSCO, Adilabad Lr.No.SE/OMC/ADB/AE(T)/F.No./D.No.85/20, dt.09.06.2020 and vide SE, OMC Circle, TSTRANSCO, Adilabad Lr.No.SE/OMC/ADB/AE(T)/F.No./D.No.84/20, dt.09.06.2020. working permission has been issued in PCCF Lr.dt.23.04.2020 with conditions as the User Agency has complied with necessary conditions for issual of such working permission for tree cutting and commencement of works.

4. I am also to enclose a copy of the letter 5th cited along with its enclosures of the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad and to request you to obtain and communicate final (Stage.II) approval, at the earliest.
