iii.	Compensatory afforestation shall be taken up the by the Forest department at the cost of the user agency and the same shall be maintained for 10 years. Only indigenous forest tree species shall be used for such plantation. Trees, If planted on the diverted area, will not be felled without the permission of the Forest Department.	Agreed.
iv.	The user agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of the Environment and Forests from time to time.	Agreed.
v.	Additional amount of the NPV of the diverted if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee shall be charged by the State Government from the user agency . The User agency shall furnish an undertaking to this effect.	Agreed. The undertaking for the same is submitted herewith.
vi.	The user agency shall seek permission from Forest Department, Dadra & Nagar Haveli for carrying out maintenance.	Agreed
vii.	The User agency shall be responsible for any loss to the flora/fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	The best possible and strict measures shall be taken to conserve the flora/fauna during construction.

viii.	All statutory provisions under various acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed.
ix.	It will be the responsibility of the User Agency to ensure that the labourer and staff engaged in construction activity do no damage forest flora and fauna.	Agreed.
x.	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval to Central Government.	Agreed.
xi.	Proper labour camps outside the forest area to be dismantled and removed. The labourers shall be sent back immediately after the completion of work.	Agreed.
xii.	All the fund received from the user agency under the project shall be transferred to CAMPA Fund only through e portal (http://forestclearance.nic.in)	The payment has been transferred towards the details mentioned in the challan generated from the website.
xiii.	The User agency has to pay Rs. 7,73,362/- towards Compensatory Afforestation of land and Rs.5,80,302/- towards Net Present Value including maintenance for 10 years.	The payment has been transferred towards the details mentioned in the challan generated from the website.
xiv.	The forest land shall not be used for any purpose other than that specified in the proposal.	Agreed.
xv.	The compliance report shall be uploaded on e portal (http://forestclearance.nic.in)	Agreed.
