

xii.	All the fund received from the user agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank A/c No. SB01025204 (CAF D&NH) in Corporation Bank, Lodhi Complex, New Delhi – 110003.
