I, am directed to invite your attention to the reference 6th cited, in which the Government of India, Ministry of Environment and Forestry, have accorded approval in-principle (Stage-I) U/s 2 of Forest (C) Act, 1980, for diversion of forest land to an extent of 2.425 ha in Kagaznagar Division of erstwhile Adilabad District (presently Komaram Bheem Asifabad District) for laying of Pipe Line and Construction of Structures in Segment-22/4 (Kagaznagar) under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal, subject to fulfillment of certain conditions as stipulated therein.

2. The Principal Chief Conservator of Forests (HoFF), Telangana State, in his letter 8th cited, has submitted condition wise compliance report on the conditions stipulated in in-principle (Stage-I) approval. The details of which are as follows:-
