
Sir,

Madam,

The in-principle approval for diversion of 17.00 Ha of forest land for underground work URI-I Stage-II HE Project, District Baramulla UT of J&K in favour of NHPC URI-I Stage-II, Baramula Jammu & Kashmir, has been accorded by Government of India, Ministry of Environment, Forest and Climate Change on 14-01-2025.

The in-principle approval accorded with several conditions and one of the conditions is that:-

“the non-forest land proposed for CA shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, will be submitted by the State Government prior to Stage-II approval”.

The non forest land proposed for CA in this proposal, has been transferred and mutated in favour of J&K Forest Department.

The Ministry of Environment, Forest and Climate Change, Government of India, vide communication dated 17-12-2024 has issued the following clarification:-

- i. Provisions of Rule 14(1) of the Van (Sanrakshan Evam Samvardhan) Rules, 2023, provides that the non-forest land identified for raising Compensatory Afforestation (CA) is to be notified as Protected Forests before final approval (Stage-II) approval is granted by the Central Government. However, in cases where non-forest land identified for CA has been transferred and mutated in favour of the State Forest Department (SFD), the Central Government may accord final approval keeping in view the fact that provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 become applicable on such lands being entered as forest in government record/record of rights.
- ii. In such cases, referred in para (i) above, the non-forest land forest land proposed for CA, shall be notified as Protected Forest under section 29 of the Indian Forest Act, 1927 of local forest Act before handing over of forest land to the User Agency by the State Government. The Nodal Officer, after notification of such non-forest lands, shall upload a copy of said notification on the PARIVESH portal.

In view of the above and as recommended by Conservator of Forests, North Circle Sopore and DFO J.V. Forest Division, it is recommended and requested for accord of stage-II (final) approval for this proposal.







- V. Litigation, if any, to be contested by the Indenting department.
- VI. The indenting department to take possession of the land within 30 days from the transfer order, and land to be put to use within 03 years failing which the land shall revert back to the Government.
- VII. The Government reserves the right to retrieve any un-utilized portion of the land from the department if the same is required for any other public purpose.



**OFFICE MEMORANDUM**

**Subject: Clarification on requirement of Cumulative Impact Assessment and Carrying Capacity Study (CIA&CCS) for expansion of existing Hydro-electric Projects (HEPs) in River Basin-reg.**

The Ministry has issued an Office Memorandum dated 28<sup>th</sup> May 2013 (copy enclosed), delineating the guidelines for streamlining of process of Environmental Clearance (EC) and Forest Clearance (FC) cases by Expert Appraisal Committee (EAC) & Forest Advisory Committee (FAC) respectively for Hydropower and River Valley Projects (HEP & RVP), which *inter-alia* states that "... (iii) *Cumulative Impact Study: Cumulative Impact study of a basin would reflect the cumulative impact of commissioned/up-coming hydro-power projects in the basin on environmental flow, biodiversity, muck disposal sites, traffic flow in the region, R&R issues, etc. While the first project in a basin could come up without insisting on cumulative study, for all subsequent hydro-power projects in the basin, it should be incumbent on the developer of the second/other project(s) to incorporate all possible and potential impact of other project(s) in the basin to get a cumulative impact assessment done. This condition shall be stipulated, at the ToRs stage itself during the EC process. Once such a cumulative impact study has been done, the same could be shared by EAC with FAC. The Cumulative impact study in respect of biodiversity component may be separately got done by one of the specialized institutes as stated at (ii) above. While making recommendation on EC/FC for such projects, the EAC/FAC will take into account the results of such cumulative studies....."*

2. The Ministry has received representation from the Ministry of Power, Government of India regarding exemption from CIA&CCS for the expansion proposal of existing HEPs in a given river basin.

3. The matter has been examined in consultation with the Expert Appraisal Committee (EAC), River Valley & Hydro-electric Projects and accordingly, it is clarified that Expansion proposals of existing HEPs, which do not result in any change in reservoir capacity (FRI + Dam height), environmental flow and modification in key components like Spillway, Intake Gates, may be carried out after joint appraisal of the EIA/EMP of existing HEPs as well as the EIA/EMP of the proposed expansion project rather than undertaking a fresh CIA/CSS study.
