- Sub: Diversion of 15.265 ha of forest land for expansion of existing Red Mud Pond at village Rengopali under Lanjigarh Tahasil in Kalahandi District by Vedanta in favour of M/s IDCO, Bhubaneswar under Kalahandi (South) Division Stage-I compliance regarding.
- Ref: Letter No. 5-ORC469/2021 BHU dated 17.11.2021 of Deputy Inspector General of Forests (C), GoI, MoEF & CC, IRO, Bhubaneswar.

Sir,

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, IRO, Bhubaneswar have accorded Stage-I/In-principle approval vice their Letter 5-ORC469/2021-BHU dated 17.11.2021 for diversion of 15.265 ha of forest land for expansion of existing Red Mud Pond at village Rengopali under Lanjigarh Tahasil in Kalahandi District by Vedanta in favour of M/s IDCO, Bhubaneswar under Kalahandi (South) Division subject to fulfillment of 13 (thirteen) nos. of conditions prior to handing over of forest land by the State Forest Department and 20 (twenty) nos. of conditions after handing over of forest land to the User Agency by the State Forest Department. The point wise compliance basing on the reports of the DFO, Kalahandi (South) Forest Division and RCCF, Bhawanipatna Circle are as follows:- A: Condition which need to be complied prior to handling over of forest land by the State Forest Department.

<u>Condition No.A(i):-</u> The User Agency shall transfer online, the Net Present Value (NPV) of 15.265 ha forest land being diverted under this proposal, as per the Order of Honorable Supreme Court of India dated 28.03.2008, 24.04.2008 & 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry Vide its letter No.5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online Portal in CAMPA account of the state concerned.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the Net Present Value (NPV) of entire area of 15.265 ha amounting to **Rs.95,55,890/-** (Ninety five lakhs fifty five thousand eight hundred ninety) only has been deposited by the User Agency in the CAMPA Account vide RTGS No. SBIN322082805026 dated 23.03.2022 and the copy of the deposit slip is enclosed as **Annexure-A1**. The DFO, Kalahandi (South) Division has issued demand notice vide letter No.- 504/3F(Lease) dated 28.01.2022 which is enclosed as **Annexure-A1**(a).

# <u>Condition No.A(ii):-</u> The identified non -forest land of 16.49 ha. For raising compensatory afforestation shall be transferred & mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the non-forest land identified in village Dangajore under Lanjigarh Tahasil of Kalahandi District for raising compensatory afforestation measuring an area 40.75 acres (16.49 Ha) has been transferred and mutated in favour of the State Forest Department. The copy of the Record of Rights issued by Tahasildar, Lanjigarh is enclosed **Annexure – A2.** The Non-Forest land has been declared as "Dangajore Protected Forest" under Section-33 of the Odisha Forest Act, 1972 by FE & CC Govt. of Odisha vide Notification No-FEE-DIV-FLD-0085-2021-(10F (Cons)-44/2021)-20899/FE&CC dated 24.11.2022. The copy of the said notification is enclosed as **Annexure-A3.** 

#### <u>Condition No. A(iii):-</u> The land identified for the purpose of Compensatory Afforestation shall be clearly depicted on a Survey of India Topo sheet 1: 50,000 scale.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the Non-Forest Govt. land identified in village Dangajore under Lanjigarh Tahasil for the purpose of CA has been clearly depicted on Survey of India Topo shee. No. E44F5 in 1:50,000 scale after duly authenticated by Forest & Revenue authorities & the Additional CA land identified in

Ghana RF of Junagarh Forest Range has been clearly depicted on Survey of India Topo Sheet No. E44F1 in 1:50,000 scale and the Toposheet Map are enclosed as **Plate-I & II**.

<u>Condition No.A(iv):-</u> The KML files of the area to be diverted, the CA areas, the Proposed Catchment area, treatment area, and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the Case may be.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the UA has submitted the shape file / KML file of the area proposed to be diverted, the CA areas, Catchment area, treatment area, WLMP area including all DGPS Survey data authenticated by ORSAC in CD form which is enclosed as **Annexure-A4**. The DFO, Kalahandi (S) Division has submitted an undertaking that the same will be uploaded in the e-Green watch portal after Stage-II approval which is enclosed as **Annexure –A4** (a).

#### <u>Condition No.A(v):-</u> All non -forest land received under C.A. in Kalahandi District should be Notified as forest under the India Forest Act, 1927 within 6 months.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the non-forest area received under CA in the instant case has already been notified as "Dangajore Protected Forest" by FE & CC Covt. of Odisha under Section-33 of Odisha Forest Act, 1972 vide Notification No-FEE-DIV-FLD-0085-2021-(10F(Cons)-44/2021)-20899/FE&CC dated 24.11.2022. The copy of the said notification is enclosed as **Annexure-A3**.

#### <u>Condition No.A(vi):-</u> CA area under degraded forest is very large and planting 200 saplings /ha seems to be very scanty. State Forest Department may consider afforest the degraded area with more saplings per ha.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the CA Scheme has been prepared as per the field condition of the site and has proposed for planting of 200 saplings per hectare in available area.

<u>Condition No.A(vii):-</u> The User agency shall transfer the cost of raising & maintaining the compensatory afforestation at the current wage rate in the consultation with state Forest Department in the account of CAMPA of the concerned state through online portal. The Scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that 16.49 ha non-forest Govt. land identified in village Dangajore under Lanjigarh Tahasil for Compensatory Afforestation in lieu of forest diversion of 15.265 ha of forest land in favour of M/s IDCO, Bhubaneswar. The DFO, Kalahandi (S) Division has prepared the CA scheme in

ANR mode by planting 200 seedlings/ha with 10 years maintenance and the scheme has been approved by PCCF (FD & NO, FC Act) with Financial Outlay for Rs.49,09,431/- only at the current wage rate of Rs.326/man day. Further, to accommodate the balance seedlings, the DFO, Kalahandi (S) Division has identified another patch of 129 ha of degraded forest land in Ghana Reserve Forest and proposed for plantation in ANR mode with 200 plants/ha with 10 years maintenance and the same scheme has been approved by PCCF (FD & NO, FC Act) with Financial Outlay for Rs.1,22,66,573/- only at the current wage rate of Rs.326/man day. Further, the DFO, Kalahandi (S) Division has revised the Financial Dutlay of both the CA scheme and Addl. CA scheme for Rs.49,34,585/- and Rs.1,24,63,350/- respectively due to enhancement of wage rate from Rs.326/- to Rs.333/- per manday. The appropriate provision has been included in the CA scheme for anticipated cost increase for work schedule for subsequent years. The DFO, Kalahandi (S) Division has raised demand vide Memo Nd.8051 Dt.27.11.2022 and the User Agency has deposited an amount of Rs.1,73,97,935/- Rs.49,34,585/- + Rs.1,24,63,350/-) towards cost of CA and Addl. CA in CAMPA Account on 11/01/2023 vide RTGS No. SBINR52023011125769476 dt.11/01/2023. The demand letter of DFO, Kalahandi (S) Division and the deposit slip are enclosed as Annexure-A5 & A5 (A).

<u>Condition No.A(viii):-</u>All the funds received from the user agency under the project shall be transferred / deposited in the CAMPA account only through e-portal (https:// Parivesh.nic.in/). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.

**Compliance:-**In compliance to the above, the RCCF, Bhawanipatna Circle has reported that all the funds i.e. NPV amounting to Rs.95,55,890/- and cost of CA amounting to Rs.49,34,585/- and cost of Addl. CA amounting to Rs.1,24,63,350/-have already been deposited by User Agency in CAMPA account in e-portal through e-Challan generated under Privesh.nic.in.

The statement of funds towards deposit of compensatory levies by the user agency in prescribed CAMPA format duly signed by the DFO. Kalahandi (South) division and countersigned by the PCCF (FD & Nodal Officer, FC Act) is enclosed as Annexure-A6.

#### <u>Condition No.A(ix):-</u>The cost of felling of trees shall be deposited by the user agency with the State Forest Department.

**Compliance:-** In compliance to the above, the User Agency has submitted an undertaking duly signed by the DFO, Kalahandi (South) division that the cost for felling of the trees from the proposed project area will be deposited with State Forest Department on receipt of estimate / demand by the concerned DFO which is enclosed as **Annexure-A7**.

<u>Condition No.A(x):-</u>The compliance report of the Stage -I approval shall be uploaded on eportal (https:// Parivesh.nic.in/).

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has uploaded the Stage-I compliance in e-portal.

## <u>Condition No.A(xi):-</u> The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the FRA Certificate has been issued by the Collector & District Magistrate, Kalahandi District in prescribed format as per FRA-2006 vide letter No.2129 dated 12.09.2023 and communicated vide letter No.2141/FRA dt.13.09 2023 alongwith Gram Sabha Resolution in English and Odia Version, SDLC and DLC Proceedings which are enclosed as **Annexure-A8** series.

## <u>Condition No.A(xii & xiii):-</u> The boundary of the proposed forest land for diversion, shall be demarcated on the ground at the project cost, by erecting four feet height reinforced cement pillars, each inscribed with it" serial no, distance from pillar to pillar and GPS co-ordinates.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the boundary of the proposed forest land for diversion has been demarcated in field by erecting 4" height RCC pillar and all the pillars marked with Sl. No., distance from pillar to pillar, GPS Coordinates has also been inscribed on those pillars and the photocopies of the pillars duly authenticated by DFO, Kalahardi (S) Division are enclosed as **Annexure-A9 & A10** respectively.

## B: Condition which needs strictly complied on field after handing over of forest land to the user agency by the State Forest Department, but the compliance in form of undertaking shall be submitted prior to Stage-II approval.

<u>Condition No.B(i):-</u> Legal status of forest land proposed for diversion shall remain unchanged.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) division that the legal status of the land shall remain unchanged which is enclosed as **Annexure-B1**.

<u>Condition No.B(ii):-</u> Compensatory afforestation shall be raised over 16.49 ha non forest land identified in village Dangajore under Lanjigarh Tahasil under Kalahandi (South) Forest Division within three years from the date of Stage-II clearances and maintained thereafter by the State Forest Department at the cost of user agency.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported the Compensatory afforestation shall be raised over 16.49 ha. in non-forest Government land identified in village Dangajore under Lanjigarh Tahasil under Kalahandi (South) Forest Division within three years from the date of Stage-II clearances and will be maintained thereafter by State Forest Department i.e. DFO, Kalahandi South Division at the cost of user agency. Accordingly, the CA scheme includes the cost of raising of plantation and maintenance for 10 years amounting to Rs.49,34,585/- has already been deposited by the User Agency in State CAMPA account.

#### <u>Condition No.B(iii):-</u> Additional compensatory afforestation shall be raised over 129 ha. Degraded forest land identified in the Ghana RF under Junagarh Range of Kalahandi (South) forest Division within three years from the date of Stage-II clearances and maintained thereafter by the State Forest Department at the cost of user agency.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the additional compensatory afforestation shall be raised over 129 ha. Degraded forest land identified in the Ghana RF under Junagarh Range of Kalahandi (South) forest Division within three years from the date of Stage-II clearances and maintained thereafter by State Forest Department i.e. DFO, Kalahandi South Division at the cost of user agency. Accordingly, the Addl. CA scheme over 129 ha. along with 10 years of maintenance in degraded forest land identified in Ghana RF under Junagarh Range of Kalahandi (South) forest Division amounting to Rs.1,24,63,350/- has already been deposited by the User Agency in State CAMPA Account.

<u>Condition No.B(iv):-</u> The species to be planted under CA /Addl. CA shall be indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation. Intensive monitoring of the plantation needs to be done and documented using Geo tagging so that the increase of canopy density and survival & growth of plantation can be Evaluated at regular interval. These reports shall be communicated to IRO periodically (Six monthly).

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the CA Scheme has been prepared with the provision to plant the indigenous species to the area and naturally growing species. Further, intensive planting technique will be followed for survival of Plantation and intensive documentation will be made by using Geo-tagging for intensive monitoring and evaluation for increase of canopy density, survival and growth of plantation could be done at regular interval and also report will be submitted to the Regional Office.

<u>Condition No.B(v):-</u> At the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Honorable Supreme Court of India.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that at the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency has furnished an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Honorable Supreme Court of India which is enclosed as **Annexure-B2**.

### <u>Condition No.B(vi):-</u> The User Agency shall obtain Environmental Clearance as per the provision of the Environmental (Protection) Act.1986 if applicable.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the Environmental Clearance in respect of the project has already been obtained from the Government of India, Ministry of Environment, Forest & Climate Change vide letter dt.06/08/2021 which is enclosed as **Annexure-B3**.

#### <u>Condition No.B(vii):-</u> No labor camp shall be allowed in the forest area.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Fores Division that no labour camp will be established in the forest area proposed for diversion which is enclosed as **Annexure-B4**.

### <u>Condition No.B(viii):-</u> No additional or new path will be constructed inside the forest area for any activity related to the project work.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that no additional or new path will be constructed inside the forest area for any activity related to the project work which is enclosed as **Annexure-B5**.

### <u>Condition No.B(ix):-</u> The user agency while executing works shall not fell any tree or damage forest growth in the surrounding forest area in any manner.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that while executing works, no felling of trees or damage to forest in the surrounding forest area in any manner which is enclosed as **Annexure-B6**.

### <u>Condition No.B(x):-</u> The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that the layout plan of the proposed area shall not be changed without prior approval of the MoEF & CC which is enclosed as **Annexure-B7**.

### <u>Condition No.B(xi):</u> The forest land shall not be used for any purpose other than that specified in the proposal.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that the forest land shall not be used for any purpose other than that specified in the proposal which is enclosed as **Annexure-B8**.

# <u>Condition No.B(xii):-</u> The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department, or person without prior approval of Ministry of environment, Forest & climate change.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that the forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department, or person without prior approval of Ministry of environment, Forest & climate change which is enclosed as **Annexure-B9**.

## <u>Condition No.B(xiii):-</u> No damage to the flora and fauna of the adjoining area shall be caused.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that no damage to the flora and fauna of the adjoining area shall be caused which is enclosed as **Annexure-B10**.

<u>Condition No.B(xiv):-</u> The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.

**Compliance:**-In compliance to the above, the RCCF, Bhawanipatna Circle has reported that DFO, Kalahandi (S) Division will monitor and take necessary mitigative measures scrupulously to ensure there is no adverse impact on the forests in the surrounding area.

# <u>Condition No.B(xv):-</u> The User agency shall explore the possibility of successful translocation of maximum numbers of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that the User agency shall explore the possibility of successful translocation of maximum numbers of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department which is enclosed as **Annexure-B11**.

### <u>Condition No.B(xvi):-</u> The period of diversion under this approval shall be co-terminus with the period of lease granted in favour of the user agency or the project life, whichever is less.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that the period of diversion under this approval shall be co-terminus with the period of lease granted in favour of the user agency or the project life, whichever is less is enclosed as **Annexure-B12**.

# <u>Condition No.B(xvii):-</u> The user agency shall submit annual self-monitoring report on compliance of stipulated condition to the Nodal Officer (FCA) of the state and concerned Integrated Regional Office of this Ministry by the end of march every year.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that the user agency shall submit annual self-monitoring report on compliance of stipulated condition to the Nodal Officer (FCA) of the state and concerned Integrated Regional Office of this Ministry by the end of march every year which is enclosed as **Annexure-B13**.

# <u>Condition No.B(xviii):-</u> Any other conditions that the Ministry of Environment, Forest & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the user agency.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that any other conditions that the Ministry of Environment, Forest & Climate Change may impose from time to time in the interest of afforestation, conservation and management of

flora and fauna in the area shall be complied by the user agency which is enclosed as Annexure-B14.

<u>Condition No.B(xix):-</u> The State Govt. and the user agency shall ensure compliances to provisions of all the Acts, Rules, Regulations, Guidelines, NGT Order(S) & Honorable Court order (S) pertaining to this project, if any, for the time being in force, as applicable to the project.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that the State Govt. and the user agency shall ensure compliances to provisions of all the Acts, Rules, Regulations, Guidelines, NGT Order(S) & Honorable Court order (S) pertaining to this project, if any, for the time being in force, as applicable to the project which is enclosed as **Annexure-B15**.

<u>Condition No.B(xx):-</u> Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guideline of Forest (Conservation) Act, 1980 as issued by this ministry "s letter No. 5 -2/2017-FC dated 28.03.2019.

**Compliance:-** In compliance to the above, the RCCF, Bhawanipatna Circle has reported that the User Agency has furnished an undertaking duly signed by the DFO, Kalahandi (South) Forest Division that violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guideline of Forest (Conservation) Act, 1980 as issued by this ministry "s letter No. 5 -2/2017-FC dated 28.03.2019to agree to the above conditions which is enclosed as **Annexure-B16**.

In view of the above, the compliance to the conditions imposed by the GoI, MoEF & CC, IRO, Bhubaneswar is sent herewith for according final approval for diversion of 15.265 ha of forest land for expansion of existing Red Mud Pond at village Rengopali under Lanjigarh Tahasil in Kalahandi District by Vedanta in favour of M/s IDCO, Bhubaneswar under Kalahandi (South) division
