In reference to your letter received cited above on the subject, this is to submit herewith the compliance report as below of the conditions stipulated therein in respect of stage-I approval granted for the proposal for diversion of 6.18 ha. of forest land for construction of flood protection work near general ground at Seijosa in Pakke Kessang District of Arunachal Pradesh seeking prior approval of the Central Government under Section 2 of the for favour of your information and necessary action:

A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

1	The User Agency shall transfer, the Net Present Value (NPV) in the revised rate of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ petition (Civil) No.202/1995 and as per the guidelines issued by the Ministry vide letters No.5-3/2007-FC dated 05.02.2009 and Ministry letter File No.5-3/2011-FC(Vol-I) dated 21.03.2022. The requisite funds shall be transferred through online portal into CAMPA account of the State concerned. 


