With reference to letter cited above, this is to submit compliance report as below of the conditions stipulated therein for favour of your information and necessary action:

A. Copnditions which need to be complied prior to handing over of forest land by the State Forest Department.

	The user agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in write petition (Civil) No 202/1995 and as per the guidlines issued by the Ministy vide letter No 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal into CAMPA Account of the State concerned. It is, therefore, requested to kindly issue necessary formal approval for diversion of 36.65 ha forestland for construction of above Transmission line under Section-2 of the Forest (Conservation) Act, 1980 at an early date.
