The User Agency- Executive Engineer, R & B Division, Godhra has already transferred payment and amount of Rs.6,51,164/- towards the cost of Compensatory Afforestation scheme and the cost of Survey & Demarcation and erection of permanent pillars if required shall be deposited in advance at prevailing wage rates Afforestation shall be maintained for 07 to 10 years. The scheme may include appropriate provision of anticipated cost increase for works scheduled for subsequent years.

- 4(a) The User Agency has already transferred payment an amount of Rs.6,19,740/- towards the Net present value deposit in CAMPA fund.
- 4(b) The User Agency has given undertaking to pay the additional amount in case there is upward revision of the rate of NPV as per page No.117 in the proposal.


