राष्ट्रिय अधिकरण के व्यव. पर वन विभाग द्वारा शुन्य 10 वृक्षों का पातन 100 वृक्षों तथा 10 से अधिक वृक्षों का पातन होने पर पातन किये जाने वाले वृक्षों का दस गुना संख्या में वृक्षों का वृक्षारोपण एवं 10 वर्षों तक किया जायेगा। इस हेतु प्रत्येक अधिकरण द्वारा वर्तमान दरों को करते हुये राशि वेबपोर्टल OSMFWP (Online Mission & Monitoring of Forest & Wildlife Finance Portal) द्वारा सृजित ई-जालान द्वारा जमा की जायेगी।

राष्ट्रिय अधिकरण द्वारा माननीय उच्चतम न्यायालय के रेट पिटीशन 202 / 1995 के अन्तर्गत आई.ए. संख्या 566 एवं भारत सरकार का संख्या 5-3/2007 - एफ. सी. दिनांक 05.02.2009 तथा पत्र 12-2/CAMPA दिनांक 09.06.2016 में दिये गए आदेशानुसार शुद्ध मूल्य (एन.पी.वी.) की निधारित राशि जमा की जावेगी। उपरोक्त के अनुसार शुद्ध वर्तमान मूल्य तथा काफी कम 566 के अनुसार

- 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and 5-3/2011-FC dated 06.01.2022 in this regard.
3. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
4. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
5. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the direction of concerned Divisional Forest Officer.
6. The KML file of the area to be diverted shall be uploaded on the e-Green watch portal with all requisite details, before issuing working permission towards line projects or submitting compliance report for seeking Final/Stage-II approval, as the case may be.
7. All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal.
8. Conditions which needs to be strictly complied on the field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Final/Stage-II approval.
1. Legal status of the forest land shall remain unchanged.
2. Forest land will be handed over to the User Agency only after required non-forest land for the project is handed over to the User Agency.
3. Compensatory afforestation shall be taken up by the State Forest Department over 0.25 ha degraded forest land (110 manjras). Village- Chaak-IAS, Tehsil- Suratsarh, Range- Jirafadal, District- Sriganganagar, Rajasthan at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and mono-culture of any species may be avoided.
4. User agency shall restrict the felling of trees to 11 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
5. Greenery shall be maintained around the boundary between the entry and exit of the fuel pump by the User Agency.
6. No damage to the flora and fauna of the adjoining area shall be caused. 7. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
8. The layout plan of the proposal shall not be changed without prior approval of Central Government.
9. No labour camp shall be established on the forest land.
10. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or Forest Development Corporation or any other legal source of alternate fuel.
1. No additional or new path will be constructed in the forest area for transportation of construction materials for execution of the project work. 12. The forest land shall not be used for any purpose other than that specified in the project proposal.
3. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of Rajasthan.
1. The User Agency shall submit the annual self compliance report in respect of the project as per the above stated conditions to the State Government Integrated Regional Office, Jaipur by the end of March every year.
2. The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Court Order (s) and NGT Order (s) pertaining to the project, if any, for the time being in force, as applicable to the project.
3. Violation of any of these conditions will amount to breach of Forest (Conservation) Act, 1980 and action shall be taken as per the MoEF&CC Guideline F. No. 11-FC dt 29/01/2018.
4. Any other condition as may be specified by the State Government.
