I, am to invite your attention to the reference 3rd cited and to inform that the Government of India, Ministry of Environment, Forests & Climate Change, R.O.(South Eastern Zone) Chennai have accorded approval in-principle (Stage-I) U/s 2 of Forest (C) Act, 1980, for diversion of forest land to an extent of **4.447 ha (Sangareddy 1.242 ha + Banswada 3.205 ha)** for laying of Pipe Line in **Segment-12/4 (Aredu)** for providing safe drinking water under Telangana Drinking Water Supply Project - in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal, subject to fulfillment of certain conditions as stipulated therein.

2. I am to further inform that the Principal Chief Conservator of Forests (HoFF), Telangana State, in her letter 5th cited, has submitted condition wise compliance report on the conditions stipulated in in-principle (Stage-I) approval. The details of which are as follows:-

It is submitted that, the Government of India, Ministry of Environment, Forests & Climate Change, R.O. (South Eastern Zone) Chennai in the reference 7th cited has accorded in-principle (**Stage-I**) approval, for diversion of forest land to an extent of **4.447 ha (Sangareddy 1.242 ha + Banswada 3.205 ha)** for laying of pipe line in **Segment-12/4 (Aredu)** for providing safe drinking water under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nizamabad" **subject to certain conditions stipulated therein**; which has been communicated vide reference 8th cited by the Prl.Chief Conservator of Forests (HoFF) to the Superintending Engineer, TDWSP (RWS&S) Circle. Nirmal (user agency) and concerned Conservators of Forests/ District Forest Officers/ Forest Divisional Officers, for taking further necessary action.
