16. The User Agency, if required, shall obtain the environment clearance under the Environment Impact Assessment Notification, 2006 issued under the Environmental (Protection) Act; 1986.
17. No labour camp will be established on the forest land and the User Agency will provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
18. The boundary of the diverted forest land will be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar.

Katara case: SC orders convict's release after 20 years in prison

New Delhi: In an important decision, Supreme Court on Tuesday held that a convict, sentenced to life imprisonment with a fixed term, will not require remission of sentence to come out of jail like a normal life imprisonment case and he will become a free man after completing the fixed term.

A bench of Justices B V Nagarathana and J V Narayana directed for the release of Sukhdev Pathani in the Katara case as he had already completed 20 years' imprisonment in March. It rejected the plea of Delhi govt, which said the court let him come out of jail only when his plea for remission of sentence was allowed by the govt.

Dismissing the submission of the govt, the bench said every convict would be in jail if this remained the attitude of the executive. "When it comes to liberty, we have to be vigilant," the bench said, allowing the plea of Pathani.

Additional solicitor general Arundhan Pathak had, appearing for Delhi govt, and senior advocate Aparajita Singh, appearing for the Katara family, submitted that there could not be an automatic release after 20 years as life imprisonment means jail till the remainder of natural life. They alleged that the convict's conduct in jail had been suspicious as he tried to influence a high court judge.

The bench, however, said the govt could file a fresh case if it wanted him to be kept in jail in the Katara case as he had completed 20 years' imprisonment.

There is no question of remission after completion of sentence. When the life sentence is quantified, then the convict has to be released after completion of the term. How can the Sentence Review Board sit over an order of the judicial authority," the bench said.

The court was hearing a plea filed by Pathani, who was sentenced to life imprisonment with a fixed term of 20 years in 2005 on charges of murdering a woman in the Katara case. He was convicted in 2005 in the Nishat Katara murder case.

On Oct 4, 2026, the Supreme Court had awarded a 25-year jail term without any benefit of remission to Vikas Yadav and his cousin Vinod for their role in the sensational kidnapping and killing of Nishat Katara. Co-accused Sukhdev Yadav was also handed down a 20-year jail term in the case.

HC to examine MP Rashid's bail plea to attend LS

New Delhi: Delhi HC Tuesday said it would examine on July 31 the bail plea of MP Rashid Sheikh's plea seeking interim bail in the Parliament's Speaker's case. A bench of justices V. Ramaswami and M. Ramesh Kumar also indicated that it was inclined to send the plea before another bench, which had originally allowed him the relief. The latest petition challenges a ruling earlier in the case, asking him to bear travel expenses of Rs.1 lakh per day for attending Parliament while in custody. Justice Chandrabudh was of the view that the plea moved by Rashid, popularly known as Engineer Rashid, seeking waiver of the travel expenses should be heard by the bench that previously heard a similar plea by him during the District session.

**Delhi HC upholds
conviction of
Patkar in 2000 case**

New Delhi: Delhi High Court on Tuesday upheld the conviction and punishment awarded to activist Medha Patkar in a defamation case filed by Union Minister VK Sasuna in 2000.

Justice Sudhanshu Kumar said the trial court order against which Patkar approached the high court, did not require any intervention as the challenge was "more in the nature of hairsplitting and legal technicalities."

HC pointed out that in the appeal, Patkar did not even refer to the text and content of the defamatory press note that had triggered the defamation suit as alleged Sasuna was "misquoting" the people of Gujarat and their resources to foreign interests, prompting the trial court to declare it a defamatory attack on his integrity and public service.

"The record suggests that the appellant is a member of Section 504 of the IPC and is clearly guilty of the offence under the said section," the bench said, upholding the conviction and punishment awarded to Patkar in the case.

Sidda meets MLAs without DKS, exposes factionalism

Bengaluru: Karnataka chief minister Siddaramanah's attempt to ease internal unrest in Congress by holding a series of meetings with party MLAs has instead intensified the ongoing power tug-of-war within the governing party, particularly between him and his deputy, H.K. Shivakumar.

The meetings, which started Tuesday, were intended to address legislators' grievances and distribute sanction letters for special development grants of Rs 50 crore. However, it exposed clear signs of factionalism. MLAs loyal to Siddaramanah and those backing Shivakumar clashed openly, with differences surfacing even in the CM's presence.

Although Shivakumar, also Bengaluru development minister and KPCF president, was not formally invited to the meetings, he was dropped by briefly and held a discussion with the CM while he was meeting MLAs to discuss Congress MP Rahul Gandhi's proposed protest in Bengaluru on Aug 4. The protest is aimed at highlighting alleged voter fraud in Bengaluru Central and Bengaluru Rural Lok Sabha constituencies.

Nevertheless, Shivakumar announced plans to convene a separate meeting with legislators, focusing on issues specific to Bengaluru. "We have no issues with the CM meeting the MLAs. I will hold a separate meeting with legislators," he said.
