

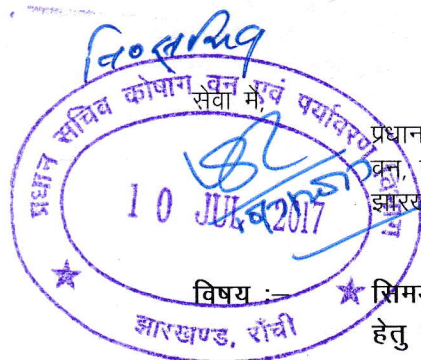

महाशय,

प्रासंगिक पत्र द्वारा विषयगत परियोजना हेतु कुल 26.814 हे० वनभूमि अपयोजन हेतु कुल 24 शर्तों पर सैद्धान्तिक सहमति प्रदान की गई है। यह परियोजना दो वन प्रमंडलों, पोड़ाहाट तथा सिमडेगा के अन्तर्गत अवस्थित है। शर्तों का अनुपालन प्रतिवेदन क्षेत्रीय मुख्य वन संरक्षक, राँची के पत्रांक 978 दिनांक 29.06.2017 एवं क्षेत्रीय मुख्य वन संरक्षक, जमशेदपुर के पत्रांक 1611 दिनांक 29.06.2017 (दोनों पत्रों की छायाप्रति संलग्न) द्वारा प्राप्त है। क्षेत्रीय मुख्य वन संरक्षक, राँची तथा जमशेदपुर के प्रतिवेदनानुसार भारत सरकार द्वारा प्रदत्त स्टेज-I में लगाई गई शर्तों का अनुपालन बिन्दुवार निम्नवत् है :-

4	Compensatory Afforestation over the degraded forest land twice in extent to the forest land being diverted shall be raised and maintained by the State Forest Department at the cost of the user agency. The user agency shall transfer the cost of plantation and its maintenance for 10 years (revised as on the date to incorporate the existing wage structure) to State Forest Department. 6	State Government shall upload the details of compensatory levies demanded and received from the project proponent on the Ministry website and submit compliance in this regard.	Compensatory Afforestation for Simdega-Manoharpur Transmission Line (portion under Porahat Forest Division) has been included in the C.A. scheme of Chaibasa-Manoharpur Transmission Line. Levy report attached as Annexure -3 and 7.
7	Transmission lines should be aligned in such a way that it involves the least amount of tree cutting. Felling of trees on the forest land being diverted shall be restricted to the bare minimum and the trees should be felled under strict supervision of the State Forest Department. The trees on such strips may be felled but after stringing work is completed, the natural regeneration will be allowed to come up.	
(b)	Outer strip may be left clear to permit maintenance of the Transmission Line.	The User agency submitted an undertaking in this regard, which is enclosed as <b>Annexure - L.</b>
(c)	In the remaining width of Right of Way felling/pollarding/pruning of trees will be done with the permission of the local Forest Officer whenever necessary to maintain the electrical clearance. The maximum sag and swing of the conductors are to be kept in view while working out the minimum clearance mentioned as above.	
(d)	The Scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in Right of Way under the Transmission Line, as prepared by the State Forest Department shall be implemented from the funds provided by the User Agency and a scheme for this shall be submitted.
