Kind attention is invited to the reference 2<sup>nd</sup> cited wherein the proposal received from the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, for diversion of 365.66 Ha (i.e. 319.02 Ha for Lower Reservoir + 22.50 Ha for Power House & TRC Outlet + 6.96 Ha for Penstock + 8.02 Ha for Intake Structure + 2.43 Ha for Tail Race Channel and 6.73 Ha for Internal Roads) of forest land in Compt. Nos. 113,114,115, 116 & 117 of Gani RF, Bethamcherla Section, Kurnool Range, Kurnool Division for establishment of 1200 MW Integrated Renewable Energy Project, Pinnapuram in favour of M/s Greenko Energies Pvt., Ltd., Hyderabad, has been forwarded to Government of India with a to obtain and communicate the approval under Section - 2 of the Forest (Conservation) Act, 1980.

In the reference 3<sup>rd</sup> cited, while according Stage -I /In-principle approval for the above Project by you, under Section-2 of Forest (Conservation) Act, 1980, subject to fulfilment of certain conditions as stipulated therein, it has been informed that after receipt of compliance report on fulfilment of the Stage-I conditions, the proposal shall be considered for final approval under Section -2 of the Forest Conservation) Act, 1980. Further it has also been indicated therein that transfer of forest land shall not be effected till final approval is granted by the Central Government in this regard.

- 3. Vide reference 4<sup>th</sup> cited, the Principal Chief Conservator of Forests (HoFF) has been requested to obtain and furnish the compliance report on the conditions stipulated by Government of India, Ministry of Environment, Forests and Climate Change, while according Stage-I approval and also requested to furnish his report in respect of the additional conditions imposed by the Government of Andhra Pradesh for taking further necessary action in the matter. The compliance report is awaited.
- 4. In the meanwhile, the User Agency i.e. Greenko Energies Pvt.Ltd. in the reference 5<sup>th</sup> cited (copy enclosed), has informed that due to COVID 19 pandemic situation, acquisition of 365.66 ha land towards Compensatory Afforestation and mutating the same in the name of Forest Department has become a huge challenge. The "Agreements of Sale" for the entire proposed CA land have been completed in the past. However transfer requires registration of "Sale Deeds" from-286 individual land parcels involving-374 farmers & their descendants, legal heirs etc. and due to increasing daily COVID 19 cases and declaration of large parts of SPSR Nellore District wherein the proposed CA lands are located as "Red Zones" and "Containment Zones", it is preventing land owners from completing necessary formalities for transfer and registration of lands which is significantly affecting the project timelines.
- 5. In view of the above difficulties, the User Agency has requested to address to Ministry of Environment, Forests and Climate Change, Government of India, New Delhi to request "the FAC to allow start of construction in forest land with a condition to transfer Compensatory Afforestation land as per forest diversion proposal on or before commissioning of the Project given the delays and difficulties faced due to global pandemic COVID-19 situation and urgent need to create Energy Storage capacities in India".
- 6. In this regard, State Government vide reference 6<sup>th</sup> cited, has requested the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh to examine the request made by the User Agency as per extant rules and furnish specific remarks to the Government immediately.
- 7. The Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, in the reference 7<sup>th</sup> cited (copy enclosed), has informed that as per condition No.vii (b) of the Stage-I approval accorded by the Government of India, the non-forest land proposed for CA shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval. Further, a copy of the original notification declaring the non forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, has to be submitted by the State Government to Government of India prior to Stage-II approval.
- 8. Further, he has stated that there is no provision under the Forest (Conservation) Act, 1980 for giving temporary working permission for Non-linear projects and work can commence only after Stage -II approval is accorded by the Government of India. Hence, apart from the condition of mutation and notification of non forest land, the User Agency also has to comply with all the other conditions prescribed in the stage-I approval of the project by the Government of India, for giving final Stage-II approval.
- 9. Accordingly, the letter of the User Agency and the remarks of the Principal Chief Conservator of Forests (HoFF), Andhra Pradesh, are herewith enclosed with a request to examine the proposal of the User Agency and communicate a suitable decision in the matter.
