(vii)	The total forest area utilized for the project shall not exceed 1.42 ha In case the land is not taken over by the user agency or the same is not used for the stipulated purpose within a period of two years, then the area shall be taken back by the Forest Department.	:	The total forest area of 1.42 ha will not exceed, and the diverted forest land of 1.42 ha will be used for stipulated purpose i.e. for formation of road within two years.
(vii)	After receipt of the compliance report of the above condition, the proposal will be considered for final approval. Transfer of forest land to the user agency shall not be effected prior to the issue of final approval. This approval shall be valid for a period of 5 years. In the event of non compliance of the above conditions this approval shall automatically stand revoked.	:	The user agency has furnished Undertaking to this effect.



Guntur without any deviation and publish the entire forest clearances granted in vobatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspapers one in vernacular language and an other in English language so as to

make people aware of permission granted to the project proponent for use of forest land for non-forestry purposes. The copies of the Forest Clearance should also be submitted to the Heads of local Bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who intend to display the same for 30 days.

The Pr.Chief Conservator of Forests (HoFF) A.P. Guntur has communicated Diverison of forest land for non-forestry purpose Stage-I/II approval accorded Payment of Compensatory levies by user agencies contain anomalies noticed in Demand notices issued by DFOs. **I. (a) Procedure for e-challan generation:**

- i. On issue of this demand notice, the user agency shall log in to Forest Clearance portal [forestclearance.nic.in](http://forestclearance.nic.in) to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

**I. (b) Procedure for Payment through RTGS:**

- iv. For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.
