



1. Executive Engineer, PR Division, Paderu shall carry out works proposed in the proposal.

2. The Executive Engineer, PR Division, Paderu has to pay the amount towards extraction of tree growth as per the scheme prepared by the D.F.O., Visakhapatnam and follow the existing procedure.
3. The works shall be carried out under the supervision of the D.F.O., Visakhapatnam.
4. The works should be carried out without any scope for violations under various rules & guidelines envisaged under F(C) Act, 1980.
5. Publish the Stage-I clearance granted and the orders issued for felling of trees in verbatim along with the conditions and safe-guards imposed by the Central Government/ Prl. Chief Conservator of Forests in two widely circulated daily newspapers one in vernacular language and the other in English language so as to make people aware of the permission granted to the Project Proponent for use of forest land for non-forest purposes.
6. The copies of the Forest Clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.
7. Any other conditions imposed by the Divisional Forest Officer, Visakhapatnam / Chief Conservator of Forests , Visakhapatnam during execution of work in the interest of protection of Forests shall be carried out at the project cost.
