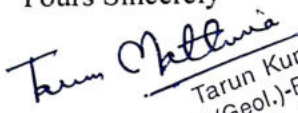

The project proposal asking amendment of the EC for **“Drilling of 45 Exploratory wells in upper Assam Shelf (South) Area encompassing Jorhat and Golaghat District, Assam”** proposed by **Oil and Natural Gas Corporation Limited (ONGC)** is placed before the SEAC held on 21/ 01/ 2023 for appraisal and detail deliberation. 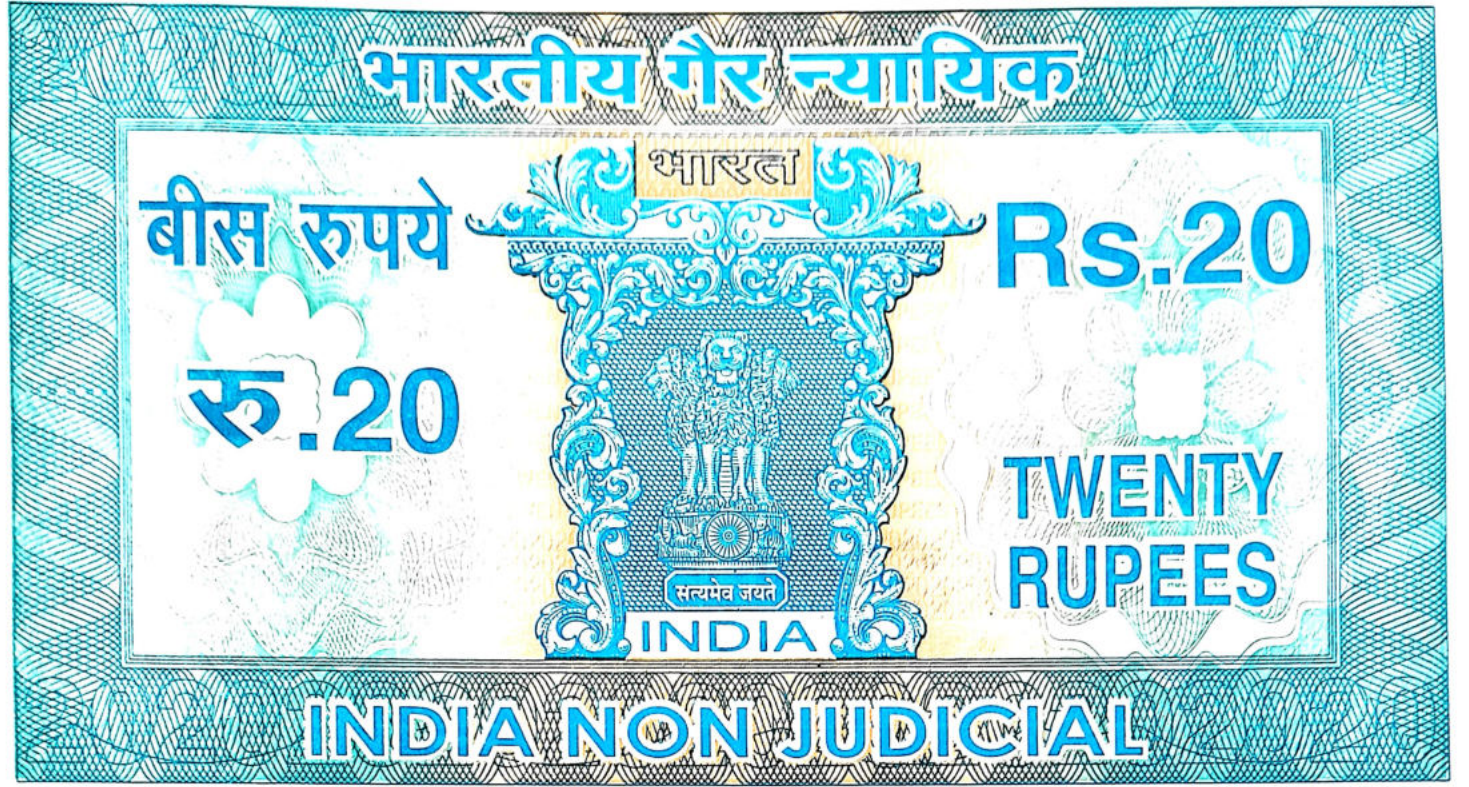

- The Company shall strictly comply with the rules and guidelines under Manufacture, Storage and Import of Hazardous Chemicals (MSIHC) Rules, 1989 as amended time to time. All transportation of Hazardous Chemicals shall be as per the Motor Vehicle Act (MVA), 1989.

### II. Air quality monitoring and preservation.

- The project proponent shall install 24×7 continuous emission monitoring system at process stacks to monitor stack emission with respect to standards prescribed in Environment (Protection) Rules 1986 and connected to SPCB and CPCB online servers and calibrate these system from time to time according to equipment supplier specification through labs recognized under Environment (Protection) Act, 1986 or NABL accredited laboratories.

**1. Undertaking Regarding Legal Status of Forest Land:**

**2. Compensatory Afforestation shall be raised by the State Government at the cost of User Agency (ONGC)**

As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided

3. **Undertaking for Net Present Value**

4. **Undertaking Demarcation of Boundary**

5. **Undertaking for Period of Diversion**

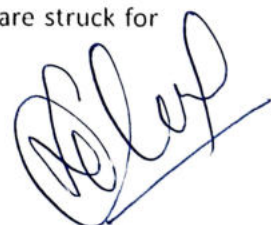

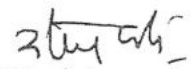
