Subject: Proposal for seeking prior approval of Central Government under Section 2 (1) ii) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for diversion of 0.024 ha forest land for construction of approach road for opening retail outlet of HPCL on the side of Chater Chowk – Santosh Bridge Road, Khata No.1008, Khesra No.3586, Thana – Alauli, Mauza - Bhadas by Shri Rajesh Kumar in Khagaria district of Bihar (Proposal No. FP/BR/Others/117859/2020)- regarding.

Sir/Madam,

I am directed to refer to Government of Bihar letter No. Van Bhumi-48/2022-704(E)/ Pa.Va.Ja.Pa. dated 15.09.2022 on the above mentioned subject, seeking prior approval of Central Government under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, and to say that the said proposal has been examined by the Advisory Committee (AC) constituted by the Central Government under Section- 3 of the aforesaid Adhiniyam.

2. After careful consideration of the proposal of the Government of Bihar and on the basis of the recommendations of the Advisory Committee (AC), the Central Government hereby agrees to accord **Stage-I / In-principle** approval under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for non-forestry use of 0.024 ha forest land for construction of approach road for opening retail outlet of HPCL on the side of Chater Chowk – Santosh Bridge Road, Khata No.1008, Khesra No.3586, Thana – Alauli, Mauza - Bhadas by Shri Rajesh Kumar in Khagaria district of Bihar subject to the following conditions:-

General conditions:

- i. Legal status of the diverted forest land shall remain unchanged;
- ii. Planting of 100 trees with iron gabion plantation shall be carried out by the State Government at the cost of the Project within two years from the date of grant of Stage II approval. Details of planting along with KML file shall be submitted along with Stage- I compliance report;
- iii. The User Agency shall transfer the cost of raising and maintaining the

- Compensatory Afforestation as per the approved CA Scheme at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal;
- iv. The State Government shall charge the Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC (pt.) dated 29.12.2023 in this regard;
 - v. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India;
 - vi. The Compensatory levies to be realized from the User Agency under the project shall be transferred/ deposited, through e-challan, in to the account of National Authority, CAMPA pertaining to the State concerned through e-portal (<https://parivesh.nic.in/>);
 - vii. The State Government shall complete settlement of rights, in term of the Scheduled Tribes and Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, if any, on the forest land to be diverted as per the sub-rule (7) of Rule 11 of the Van (Sanrakshan Evam Samvardhan) Rules, 2023;
 - viii. The complete compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>);
 - ix. The KML files of proposed area for diversion and planting of 100 trees shall be uploaded on the e-Green watch portal with all requisite details;
 - x. ***The User Agency shall pay the five (5) times penal NPV for the extent of violation done plus 12 percent simple interest from the date of raising of such demand till the deposit is made by the User Agency.***
 - xi. ***The Ministry has issued guidelines dated 21.01.2026 prescribing penal compensatory afforestation in cases where forest land has been used in violation of the provisions of the Adhinyam. Accordingly, the State Government shall ensure compliance with the said guidelines and identify land towards penal compensatory afforestation in lieu of forest land used in the violation of the Adhinyam along with supporting documents such as the KML file, Compensatory Afforestation scheme, suitability certificate, etc. The compensatory levies corresponding to the penal CA shall be deposited in the account of the State CAMPA, and the same shall be duly intimated to the Ministry.***
 - xii. ***Penal compensatory afforestation proposed by the State Government***

shall be verified by Regional Office, Ranchi and report shall be sent to the Ministry for examination along with CA details during submission of compliance report of Stage- I approval.

- xiii. ***Action under section 3A/3B of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 be initiated by Regional Office, Ranchi, as applicable;***
- xiv. The user agency shall explore the possibility of translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department;
- xv. The cost of felling of trees shall be deposited by the User Agency with the State Forest Department;
- xvi. The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required;
- xvii. No labour camp shall be established on the forest land and no work shall be allowed after sunset;
- xviii. The User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
- xix. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
- xx. The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS coordinates;
- xxi. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
- xxii. The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- xxiii. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government;
- xxiv. No damage to the flora, fauna or the environment of the adjoining area shall be caused; Adequate measures to ensure no damage to the adjoining areas should be taken by the User Agency at the project cost;
- xxv. The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area;
- xxvi. Any tree felling shall be done only when it is unavoidable and that too under

strict supervision of the State Forest Department;

- xxvii. The User Agency shall submit the annual self-compliance report in respect of the above stated conditions to the State Government, concerned Regional Office and to this Ministry by the end of March every year regularly;
- xxviii. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife shall be carried with by the State Government and user agency;
- xxix. The user agency shall comply all the provisions of all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project; and
- xxx. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 and action would be taken as prescribed in para 1.16 of Chapter 1 of the consolidated guidelines and clarifications issued under Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023 as issued by this Ministry's letter No. 5-2/2017-FC dated 29.12.2023.

After receipt of compliance report on fulfilment of the conditions mentioned above, the proposal shall be considered for final approval under section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980. Transfer of forest land shall not be affected till final approval is granted by the Central Government in this regard.

Sub: Guidelines prescribing penal compensatory afforestation (PCA) in the cases involving violation of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 – reg.

Madam/Sir,

I am directed to refer to the above-mentioned subject and to inform that matter related to imposition of penal compensatory afforestation, in cases involving violation of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 (hereinafter referred as 'Adhiniyam') has been duly examined in the Ministry and accordingly, following guidelines are issued:

As per the provisions of section 2(1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 (as amended), read with the provisions of section 3B, all acts related to 'de-reservation of forests or use of forest land for non-forest purpose or any contravention of any of the provisions of section 2, without obtaining the prior approval of the Central Government under Section 2(1) of the 'Adhiniyam', are treated as violations or offences under the Adhiniyam.

Hitherto, cases of violation have been examined on a case-to-case basis in the Ministry. Upon due consideration, it has been deemed necessary to prescribe guidelines for the imposition of penal compensatory afforestation. Accordingly, cases involving violations of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 (as amended), are hereby classified into specified categories, and the corresponding guidelines for the imposition of penal compensatory afforestation are set out thereunder -

1. Category A

Cases where User Agencies are entitled to provide degraded forest land, under the control and management of Forest Department, as specified under sub rule (1), (4) and (5) of Rule 13

of the Van (Sanrakshan Evam Samvardhan) Rules, 2023, for the purpose of undertaking compensatory afforestation.

Penal Compensatory Afforestation:

In cases of violation of the provisions of the *Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980*, the concerned User Agency shall be liable to provide non-forest land equal to the area of the forest land diverted without due approval of the Central Government or used in violation of the said Adhinyam or in cases where the User Agency fails to provide non-forest land equal to the area of the forest land diverted without due approval of the Central Government, the agency shall deposit an amount equivalent to two (2) times the Net Present Value (NPV) of the forest land used or diverted in violation of the said Adhinyam.

Where non-forest land or two-times NPV is provided as mentioned above, the user agency shall also bear the entire cost of raising compensatory afforestation thereon, cost of maintenance of the plantation raised on such land for a period of **ten (10) years**, in accordance with a site-specific afforestation scheme to be prepared with the approval of the competent authority in the Ministry.

The non-forest land so provided shall be transferred and mutated in favour of the State Forest Department or notified as forest land under the Indian Forest Act, 1927 or the relevant local forest laws, as applicable, prior to the grant of Final (Stage-II) approval as provided for under the provisions of Van (Sanrakshan Evam Samvardhan) Rules 2023 and the amendments to the Guidelines issued on 29th Nov, 2023.

The NPV amount to be realized as mentioned above shall be deposited in relevant heads with the **Compensatory Afforestation Fund Management and Planning Authority (CAMPA)**, as defined in the demand notice, by the User Agency and shall be utilized by the State Forest Department strictly for the purposes specified under **Section 6(b)** of the *Compensatory Afforestation Fund Act, 2016*, in accordance with the provisions thereof.

2. Category B (I)

Cases where the User Agency is not entitled to avail degraded forest land (DFL) to fulfil the mandatory requirement of compensatory afforestation and has provided **non-forest land (NFL)**, as specified

under **Rule 13(1)** of the *Van (Sanrakshan Evam Samvardhan) Rules, 2023*.

Penal Compensatory Afforestation:

In such cases involving violation of the provisions of the *Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980*, the concerned user agency shall be required to provide non-forest land equal in extent to the forest land diverted or used in violation of the said Adhiyam.

In addition, the User Agency shall also provide the entire cost of raising compensatory afforestation, including cost of maintenance of the plantation raised on such land for a period of **ten (10) years**, in accordance with a site-specific afforestation scheme to be prepared with the approval of the competent authority i.e. MoEFCC.

The non-forest land so provided shall be transferred and mutated in favour of the State Forest Department or notified as forest land under the Indian Forest Act, 1927 or the relevant local forest laws, as applicable, prior to the grant of Final (Stage-II) approval as provided for under the provisions of *Van (Sanrakshan Evam Samvardhan) Rules 2023* as amended on 31st Aug,2025.

The NPV amount to be realized as mentioned above shall be deposited in relevant heads with the **Compensatory Afforestation Fund Management and Planning Authority (CAMPA)**, as defined in the demand notice, by the User Agency and shall be utilized by the State Forest Department strictly for the purposes specified under **Section 6(b)** of the *Compensatory Afforestation Fund Act, 2016*, in accordance with the provisions thereof.

3. Category B (II)

Cases where the User Agency is not entitled for degraded forest land for fulfilling the mandatory requirement of compensatory afforestation and has provided **revenue forest land**, recorded as forest in Government records, other than forest land notified under the *Indian Forest Act, 1927*, as specified under **Rule 13(1)** of the *Van (Sanrakshan Evam Samvardhan) Rules, 2023*.

Penal Compensatory Afforestation:

In cases involving violation of the provisions of the *Van (Sanrakshan*

Evam Samvardhan) Adhinyam, 1980, the concerned user agency shall be required to comply with **either** of the following, as applicable:

- (a) provide **non-forest land equal in extent** to the forest land diverted or used in violation of the said Adhinyam; **or**
- (b) pay an amount equal to **two (2) times the Net Present Value (NPV)** of land equal in extent to the forest land so diverted or used for non-forestry purposes.

In either situation, the User Agency shall also provide the entire cost of raising compensatory afforestation, including cost of maintenance of the plantation raised on such land for a period of **ten (10) years**, in accordance with a site-specific afforestation scheme to be prepared with the approval of the competent authority i.e. MoEFCC.

The non-forest land so provided shall be transferred and mutated in favour of the State Forest Department or notified as forest land under the Indian Forest Act, 1927 or the relevant local forest laws, as applicable, prior to the grant of Final (Stage-II) approval as provided for under the provisions of Van (Sanrakshan Evam Samvardhan) Rules 2023 as amended on 31st Aug, 2025.

The NPV amount to be realized as mentioned above shall be deposited in relevant heads with the **Compensatory Afforestation Fund Management and Planning Authority (CAMPA)**, as defined in the demand notice, by the User Agency and shall be utilized by the State Forest Department strictly for the purposes specified under **Section 6(b)** of the *Compensatory Afforestation Fund Act, 2016*, in accordance with the provisions thereof.

The aforesaid penal provisions shall be implemented within a period of **two (2) years** from the date of issuance of diversion order of the corresponding forest land by the State Government, in accordance with **Rule 14(2)** of the *Van (Sanrakshan Evam Samvardhan) Rules, 2023*.

Penal Levies to be finalized after Site Inspection : The imposition of penal compensatory afforestation measures shall be contingent upon, and subject to verification and assessment during the site visit undertaken by the Regional Office or any other officer of the MoEFCC nominated, for the purpose. During such site visit, based on the assessment of environmental damage in the forest area, any additional restoration measures proposed by the inspecting officer,

shall also be placed before the Advisory Committee for necessary consideration and approval.

The restoration measures, to the extent that the diverted forest land or revenue forest land is available for restoration or extending to the impacted adjoining areas as decided by the competent authority, may, *inter-alia*, include but not be limited to the following indicative options:

- Soil and moisture conservation works, such as contour trenches, check dams, and gully plugging,
- Removal of invasive species and reintroduction of native flora;
- Habitat restoration for wildlife, including creation of waterholes, salt licks, or ecological corridors;
- Any other site-specific intervention deemed necessary by the Advisory Committee.

The Forest Advisory Committee (FAC), while considering such proposals, shall ensure that the measures proposed to be undertaken including the levy of NPV are proportionate to the scale of damage, technically feasible, and aligned with the objectives of ecological restoration and sustainable forest management. The activities proposed to be undertaken by the State Forest Department, as specified above under penal compensatory afforestation, shall be incorporated in the Annual Plan of Operation and submitted to the Executive Committee of the National Authority, Compensatory Afforestation Fund Management and Planning Authority, for approval. The plantation/ ecosystem restoration works shall be carried out on the additional land identified for penal compensatory afforestation, using the funds deposited for this purpose by the User Agency into the appropriate account/head/sub head of the respective State/UT CAMPA, managed by the National Authority (CAMPA).

The above guidelines are intended to serve as guiding principles for the concerned authorities and the discretion of the Competent Authority shall be final, in accordance with the provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, the rules made thereunder, and other applicable laws.
