This is with reference to queries/ EDS raised by Govt. of India, MoEFCC, RO, Ranchi vide letter referred dated 30.07.2024 which has been forwarded vide your letter dated 09.08.2024 to NHAI for necessary compliances. - 3. User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision and permission of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department. 
