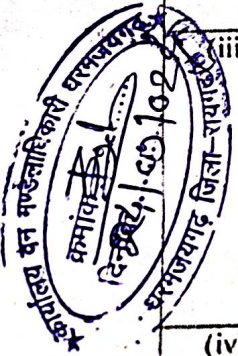


उपरोक्त विषयांतर्गत लेख है कि प्रस्तावित 220/132/33 के.व्ही. उपकेन्द्र धरमजयगढ़ (गाम-हाटी) हेतु चिन्हांकित भूमि का वन संरक्षण अधिनियम 1980 के अंतर्गत गैर वानिकी उपयोग हेतु संदर्भित पत्र के माध्यम से प्रथम चरण स्वीकृति 24 बिन्दु अधिरोपित शर्तों के साथ भारत सरकार पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय एकीकृत क्षेत्रीय कार्यालय अरण्य भवन नवा रायपुर द्वारा प्रदाय किया गया है। उक्त अधिरोपित शर्तों का पालन प्रतिवेदन छ.स्टे.पा.द्रां.कं.लि. द्वारा नियुक्त अधिकृत अधिकारी कार्यपालन अभियंता (सिविल) संभाग रायगढ़ द्वारा आपकी ओर अग्रिम कार्यवाही हेतु सादर प्रेषित है :-

(ii) (a)	Compensatory Afforestation shall be taken up by the User Agency carried out over 14.00 ha Orange Forest land in Bhundi, Bahri Khasra No. 124/2 k (8.00 ha) and 461/1 (6.00 ha) at Village - Bhundi, Bahri Range-Chhal, Dharamjaigarh Forest Division, Dist- Raigarh at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and minoculture of any species may be avoided;	शर्त आवेदक संस्थान को मान्य है।
(ii) (b)	The Orange Forest land Proposed for CA shall be transferred and mutated in the name of Forest Department and Notified as RF/PF prior to Stage-II approval. A copy of the original notification declaring the non-forest land unde Section-4 or Section 29 of the Indian Forest Act, 1927, or under relevant section of the State Forest Act as the case may be, will be submitted by the State Government Prior to Stage-II approval.	शर्त आवेदक संस्थान को मान्य है।
(iii)	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.	शर्त आवेदक संस्थान को मान्य है।

(iv) NPV (b)	Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. (v)	The total project affected trees are 189, comprised of 53 trees above 90 cm girth and the remaining 136 trees below 90 cm girth class. Any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.	शर्त आवेदक संस्थान को मान्य है।
(vi)	The User Agency shall submit the avi-fauna conservation plan for birds species found in the area. A report on the same shall be submitted to Integrated Regional Office along with the compliance Report.	Avi-fauna conservation plan is submitted to DFO Dharamjaigarh.
(vii)	All the funds received from the User Agency under the project shall be transferred/deposited to CAMPA fund only through e-portal. (ix)	The wires from the substation to the distribution lines should be insulated cables to prevent hooking by rural farmers, thereby preventing the possibility of elephant death.	शर्त आवेदक संस्थान को मान्य है।

(xi)	The State Government of Chhattisgarh/Nodal Officer (FCA), Forest Department of Chhattisgarh shall ensure settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007) before issuing an order for handing over of forest land to the User Agency as per Rule-9 (6) (b) (ii) of Forest (Conservation) Rules, 2022 dated 28.06.2022.	शर्त आवेदक संस्थान को मान्य है।
(xii)	To improve the Forest/Tree cover and to reduce pollution in the State, as mandated in National Forest Policy, 1988 and Environmental (Protection) Act, 1986 respectively, the User Agency in consultation with local DCF shall raise at least 2500 seedlings of forestry species along with bamboo, fruit bearing , medicinal,	शर्त आवेदक संस्थान को मान्य है।

	ornamental and indigenous/local for 10 years. At least 50% of seedlings shall be planted by User Agency in the vicinity of project area including forest area and for hand holding with local people residing in vicinity of proposed road. User Agency shall voluntarily distribute remaining 50% of seedlings as per choice of villagers free of cost. A compliance report including species wise details of seedlings raised, location of plantation area and details of villagers whom seedlings have been distributed need to be prepared every six month and submitted to Regional Office of MoEF&CC.	
(xiii)	User Agency shall obtain Environmental Clearance as per the Provisions of the Environmental (Protection) Act, 1986 if applicable.	शर्त आवेदक संस्थान को मान्य है।
(xiv)	The layout plan of the proposal shall not be changed without prior approval of Central Government.	शर्त आवेदक संस्थान को मान्य है।

(xvi)	Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department of the Forest Development Corporation or any other legal source of alternate fuel.	शर्त आवेदक संस्थान को मान्य है।
(xvii)	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.	शर्त आवेदक संस्थान को मान्य है।
(xviii)	No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.	शर्त आवेदक संस्थान को मान्य है।
(xix)	The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.	शर्त आवेदक संस्थान को मान्य है।

(xxi)	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.	शर्त आवेदक संस्थान को मान्य है।
(xxii)	Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dated 29.01.2018.	शर्त आवेदक संस्थान को मान्य है।
(xxiii)	Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.	शर्त आवेदक संस्थान को मान्य है।
