No Conditions Compliance 1A-1 The legal status of forest land shall remain unchanged i.e. Agreed shall remain Reserved / Protected / Village / other types of forests as the case may be. 2 No felling of tree shall be involved in the implementation of Agreed the proposal. 3 Compensatory afforestation shall be taken up by the Forest Agreed Department at the cost of the User Agency and the same shall be maintained for 10 years. Only indigenous forest tree species shall be used for such plantation.
