3	Compensatory Afforestation shall be taken up by the Forest Department at the cost of the User Agency and the same shall be maintained for 10 years. Only indigenous forest tree species shall be used for such plantation. Trees, if planted on the diverted area, will not be felled without the permission of the Forest Department, DNH.	Agreed. 4	The user Agency shall pay the Net Present Value (NPV) of diverted forest land at the rates stipulated by Ministry of Environment and Forests from time to time.	Agreed.
5	Additional amount of NPV of the diverted forest land if any, becoming due after finalization of the same by Hon'ble Supreme court of India on receipt of the report from the Expert Committee, shall be charged by the state Government from the User Agency. 8	The User Agency shall obtain the Environmental Clearance before issue of the formal order.	Agreed.

10.	The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar.	Agreed.
11.	It will be the responsibility of the User Agency to ensure that the labourers and staff engaged in construction activity do no damage forest flora and fauna.	Agreed.

13.	Proposed labour camps outside the forest area to be dismantled and removed. The labourers shall be sent back immediately after the completion of work.	Agreed.

The User Agency shall transfer / deposit Rs. 11,47,047/- (Rupees Eleven Lakh Forty-Seven Thousand Forty-Seven Only) towards compensatory Afforestation including maintenance for 10 years and Rs. 9,20,220/- (Rupees Nine Lakh Twenty Thousand Two Hundred Twenty only) towards Net Present Value of the land (NPV).
