iv.	The pipeline shall be along the road within existing right of way not falling in National Parks and Wildlife Sanctuaries.	Agreed.
v.	Compensatory afforestation shall be taken up the by the Forest department at the cost of the user agency and the same shall be maintained for 10 years. Only indigenous forest tree species shall be used for such plantation. Trees, if planted on the diverted area, will not be felled without the permission of the Forest Department, DNH.	Agreed. vi.	The user agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of the Environment and Forests from time to time.	Agreed.
vii.	Additional amount of the NPV of the diverted if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee shall be charged by the State Government from the user agency . The User agency shall furnish an undertaking to this effect.	Agreed. The undertaking for the same is submitted herewith.
viii.	The user agency shall seek necessary clearance under Wildlife Protection Act, 1972 as the proposed project is passing through DNH Wildlife Sanctuary.	Not applicable.

The User agency has to pay Rs.8,91,819/- (Rupees : Eight Lakh Ninety One Thousand Eight Hundred Nineteen only) towards Compensatory Afforestation including maintenance for 10 years and Rs.6,69,507/- (Rupees : Six Lakh Sixty Nine Thousand Five Hundred Seven Only) towards Net Present Value of land. xvii.	The forest land shall not be used for any purpose other than that specified in the proposal.	Agreed.


