The Government of India, Ministry of Environment, Forest & Climate Change has delegated the power for general approval to the State Governments of various categories like optical fiber cables, underground laying of telephone lines and underground laying of drinking water supply pipelines from time to time under section-2 of the Forest (Conservation) Act, 1980 for diversion of forest land.

The Gol, MoEF&CC has extended the said general approval to underground laying of CNG/PNG pipelines along the roads within existing right of way not falling in National Parks, and Wildlife Sanctuaries, without felling of trees, where the maximum size of the trench is not

more than 2.00 meter depth and 1.00 meter width subject to fulfilment of conditions stipulated in the Handbook of Forest Conservation Act, 1980 & Forest Conservation Rules, 2003 (Guidelines & Clarifications) Year 2019 in Chapater-4(4.2).

In view of the above, the undersigned is pleased to convey the State Government's "in principle" approval for In-principle (Stage-I) approval of Government of Gujarat under Forest (Conservation) Act, 1980 for Diversion of 0.04324 ha. Protected Forest land for laying 4" dia steel gas pipeline connectivity to Kanubhai Rabari SGL CNG Station, Dehgam Talka Dehgam Dist. Gandhinagar in favour of Chief Manager (TS&P), Sabarmati Gas Ltd., Gandhinagar subject to the following conditions:-

- This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2. The Net Present Value (NPV) for the area to be diverted under the proposal shall be deposited by the user agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008 and 09.05.2008 in IA-566 in W.P.(Civil) No. 202/1995 and as per the guidelines issued by the MoEFCC vide letters No.5-1/1998-FC(pt-II) dated. 18,09.2003 as well as letter No.5-2/2006-FC dated 03.10.2006 and 5-3/2007-FC dated 05.02.2009 in this regards.

- 7. User agency will have to restore the forest land after use/ maintenance work. No tree shall be cut.
- 8. User agency will be liable to compensate any loss to Forests/Environment caused due to the use of the said land by the user agency.
- Project area is not a part of Protected area/Sanctuary/National Park and the project area is
 85.00 Km. away from the Thol Bird Sanctuary.

- 11. Gas pipe line will be laid underground in the trench of maximum depth of 2.00 meters and width of 0.4 meters, in between rows of road side plantation.
- User Agency shall submit the details regarding compliance of MoEF's guideline dated 03.08.2009 and 05.02.2013 with regard to the Scheduled Tribe & Other Forest Dwellers (Recognition of Forest Rights), Act, 2006. FRA shall be uploaded on e.portal (https://parivesh.nic.in.) before Formal Approval.
