- The Complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.25712 Ha. of Forest area proposed for diversion.
- The diversion of forest land for facilities managed by the government as required Under the section 3 (2) of FRA have been completed.
- The proposal does not involve recognised rights of Primitive tribal groups and pre agricultural communities.
