With reference to above said matter, In-Principle approval has been granted vide letter reference (1) above for diversion of 8.40 ha. of Protected Forest Land for Widening & Strengthening of Talala to Ankolvadi road SH-98 between km. 69/000 to 53/000 in Talala taluka of Gir-Somnath. Demand Note towards Net Present Value (NPV) & CA Scheme has been received from your good office vide letter reference (2) above. With reference to the above subject and as per the instructions through letter under reference, this office is hereby submitting the status cum compliance of necessary conditions for your kind consideration.
