Adani Green Energy Thirty Limited was granted In-Principal (Stage 1) approval by MOEFCC vide its letter dated 06.02.2023 mentioned under reference 2 for diversion of 226.3223 ha. Protected Forest land for construction of 765 KV D/C transmission line project from Khavda to PGCIL substation Bhuj in Kachchh District. Thereafter, detailed compliance report to conditions mentioned in the In-Principal (Stage 1) approval including FRA certificate issued by District Collector, Kutch for the said project was submitted on 10.03.2023 for processing of Stage 2 approval.
