With reference to the aforementioned subject, it is submitted that, out of the three violations reported as per the findings of the committee, it is hereby clarified that Violation Number 1 relating to the Construction of Patwar Bhawan and Violation Number 3 relating to the Construction of Mahila Mandal Bhawan does not constitute a violation under the purview of Forest Conservation Act, 1980.

For Violation Number 2 relating to the construction of the road, as per the records of the concerned department, the officers responsible for the execution of the works, flagged by the Deputy Forest Superintendent (Central), have retired from the services (copy enclosed). It is further reported that the said works were carried out as per the procedure laid down in the HPPWD manual. However, if the said works falls under the purview of the violation of the FC Act, 1980, suitable action for imposition of penalty may be taken as per para 1.21 of the Handbook of FC Act, 1980 and FC Rules, 2003 (Guidelines and clarifications), 2019.

Information about the metaling of road patch of 0.27 ha in link road from NIT Hamirpur to Dulana Muthan Harijan Basti via Khasgran, Hamirpur.

In continuation to this office letter even file No.13752 dated-24-11-2023, it is further added that the metalling/tarring work of link road Hamirpur to Dulana via Khasgran to Muthan has been done as per budget in finance year 2005-2006 under head OTMNP (5050-04-337-02) and financial year 2007-08 under NABARD RIDF (5054-04-337-03) on already traceout & formation cutting done prior to 1999. As per PWD manual the department doesn't ascertain the status of land for metaling/ tarring where formation/cutting work is already done by some other agencies like panchayat/ RDD.
