

Letter of intent for grant of permission for change of land use for setting up of a Retail Outlet (petrol pump) over land falling in the revenue estate of village Dabwali Distt. Sirsa- Sh. Suresh Kumar S/o Sh. Ram Kumar.

- 1. Your request for grant of permission for change of land use for setting up of Retail Outlet (Petrol Pump) over land measuring 1232.18 sq. mtrs. bearing khasra no. 131//23/2/2 min. of revenue estate of village Dabwall and the limits of Municipal Committee, Dabwali as per enclosed site plan, has been considered and it has been decided, in principle, to grant permission for change of land use on this land under the provisions of Section 203E(2)(a) of the Haryana Municipal Act, 1973.
- Therefore, you are hereby required to fulfil the following terms & conditions 2. and submit the following documents as pre-requisite:
 - An agreement deed on the prescribed format on the Non-Judicial Stamp Paper of Rs. 100/-:(specimen enclosed)
 - A sum of Rs. 80/- on account of deficient scrutiny fee for the additional area measuring 7.8 sq. mtrs.
 - A sum of Rs. 1,23,218/- on account of conversion charges calculated iii. @ Rs. 100/- per sq. mtr. for 1232.18 sq.mtrs. to be sent through bank draft drawn in favour of the Chief Administrator, Haryana Urban Infrastructural Development Board payable at Panchkula.
 - An affidavit on non-judicial stamp paper of Rs. 10/- duly attested by Ist Class, Magistrate to the effect that:
 - a) No other application for grant of licence/CLU permission for the Khas a no. covered under the present CLU application stand submitted by you, which is pending for consideration/orders.
 - b) You shall deposit 10% of the gross EDC amount(updated) when the land shall be included in urbanizable zone, 40% when the 'and in the sector shall be acquired by HSVP and the balance 50%, in four annual equal installments along with interest @ 15% p.a.
 - You shall deposit the internal Development charges to Government/ HSVP/ Municipal Council, Sirsa whenever demanded by the Development authority.
 - You shall give at least 75% employment to the domiciles of Haryana as per the provisions of Haryana State Employment of Local Candidates Act, 2020. A quarterly report regarding the employment shall be furnished to the Joint Director, District Industries Centre, Sirsa and on designated portal in such form as prescribed by the competent Authority under the provision of Haryana State Employment of Local Candidates Act, 2020.
 - You shall not object acquisition of land from your site, whenever required for widening of road/service road in future.
 - You shall not object laying of trunk services whenever required to be laid from your site, in future.
 - An undertaking on Non-Judicial Stamp Paper of Rs. 10/- that:
 - a) You shall pay the additional amount of Conversion Charges for any variation in area at site in lump sum within 30 days as and when detected and demanded by the Director, Urban Local Bodies, aryana, Panchkula.
