#### UNDERTAKING

I Vijay Kumar Patel, General Manager, Gurgaon Retail Regional Office, Hindustan Petroleum Corporation Ltd applied for Diversion of Forest Land (0.0177 Hectare) for taking access permission of Proposed petrol pump of "M/s HPCL" on Faridabad WML (NH-2) New NH-44 to Ballabgarh Sohna Road, at Km. 1.800 (LHS), in Village Ranhera Khera, Mustil No. 19, Killa No. 5/1/1, Tehsil- Ballabgarh.

For the above-mentioned subject we hereby undertake that: -

- (B) i That we shall not change condition of forest land.
- ii We hereby undertake that the number of proposed trees / plants to be cut shall not exceed in any way the number shown in the proposal and there will be no harm to wildlife during felling of trees. Cutting of trees/plants will be done in supervision of Forest State Divisional Department and expense related to cutting has already deposited in department.
- iii Point No. 2(iii) is related to Forest Department.
- iv Point No. 2(iv) is related to Forest Department
- v Point No. 2(v) is related to Forest Department.
- vi We hereby undertake that the forest land will not be used for any purpose other than that shown in the proposal.
- vii We hereby undertake that whenever the amount of NPV will be increased, the user agency will be bound to deposit the increased amount of NPV.
- viii That we shall again obtain NOC after 15 years.
- ix That we shall do a plantation of light crown tree within 1.50m periphery boundary of fuel station.
- x That we shall do a plantation on entry/ exit and separator island. No commercial use of the island.
- xi That we shall do not damage the adjoining forest and forest land. We shall make all efforts to save the forest and forest land.
- xii That the diverted land shall not be transferred to any agency/ department/ other person without the permission of the Central Government.
- xiii That we shall not change the layout plan without permission of the Central Government.
- xiv That we shall dispose of the garbage as per plan.
- xv The we shall bear no objection in the condition applicable by Regional Officer for Protection and Development of wild Animal.

- xvi That we undertake that if necessary, we will obtain environmental clearance as per Environment (Protection) Act 1986.
- xvii That we undertake that violation of any of these conditions will be a violation of the Forest Conservation Act, 1980 and the guidelines mentioned in the Handbook of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 (guidelines & clarifications), 2019 of the Ministry of Environment, Forest and Climate Change and any action will be taken accordingly to rules 1.21 mentioned therein .
- xviii Point No. xviii is related to Forest Department.
