1. यह कि वन भूमि की विधिक परिस्थिति बदली नहीं जाएगी।
2. यह कि कोई वृक्ष / पौधा बाधक नहीं है इसलिए कोई वृक्ष व पौधा नहीं काटा जाएगा।
3. वन भूमि का प्रयोग प्रस्ताव में दर्शाए गए उद्देश्य के अलावा किसी अन्य उद्देश्य के लिए नहीं किया जाएगा।
4. माननीय उच्चतम न्यायालय के आदेशानुसार जब कभी भी एन.पी.वी की राशि बढ़ाई जाएगी तो उस बढ़ी हुई एन.पी.वी. राशि को केम्पा हरियाणा के लेखा में जमा करवाने के लिए इंद्रप्रस्थ गैस लिमिटेड बाध्य होगी।
5. साथ लगते वन और वन भूमि को किसी तरह का कोई नुकसान नहीं पहुंचाया जाएगा और वन और भूमि को बचाने के लिए सभी प्रयत्न किए जाएंगे।
6. स्थानावरण के लिए प्रस्तावित वन भूमि को सरकार की पूर्व अनुमति के बिना किसी भी परिस्थिति में किसी अन्य एजेंसी या व्यक्ति विषेश को हस्तान्तरित नहीं किया जाएगा।
7. सरकार की अनुमति के बिना प्रस्ताव की ले आउट प्लान को बदला नहीं जाएगा।
8. वन भूमि पर किसी भी प्रकार का कोई श्रमिक शिविर नहीं लगाया जाएगा।
9. इंद्रप्रस्थ गैस लिमिटेड द्वारा वाछित भूमि संरक्षण पैमाने उपयोग किए जाएंगे, जिसके लिए इंद्रप्रस्थ गैस लिमिटेड द्वारा वर्तमान दरों पर धन राशि उपलब्ध करवाई जाएगी।
10. इंद्रप्रस्थ गैस लिमिटेड द्वारा श्रमिकों तथा कार्यस्थल पर कार्यरत स्टाफ को अधिमानतः वैकल्पिक ईंधन उपलब्ध करवाया जाएगा ताकि साथ लगते वन क्षेत्र को किसी प्रकार के नुकसान तथा दबाव से बचाया जा सके।
11. प्रयोक्ता एजेंसी राज्य के मुख्य वन्य जीव संरक्षक द्वारा तैयार की गई योजना के अनुसार उस क्षेत्र के वनस्पति और प्राणी समूह के संरक्षण तथा परिरक्षण में राज्य सरकार की सहायता करेगी।

12. यदि आवश्यक हो तो इन्द्रप्रस्थ गैस लिमिटेड पर्यावरण (सुरक्षा) अधिनियम 1986 के अनुसार पर्यावरणीय समाशोधन प्राप्त करेगी।
13. स्थानान्तरित वन भूमि की सीमाये इन्द्रप्रस्थ गैस लिमिटेड के खर्च पर 4 फीट उंचे सीमेंट के खम्भों द्वारा चिह्नित की जाएंगी। प्रत्येक खम्भे पर कम संख्या डी0जी.पी.एस निर्देशांक तथा एक खम्भे से दूसरे खम्भे की दूरी आगे तथा पीछे लिखी जाएगी।
14. कूड़ा कर्कट निपटान वन विभाग द्वारा जारी योजना के अनुसार किया जाएगा।
15. खाई (trench) की चौड़ाई एक मीटर से अधिक व गहराई दो मीटर से अधिक नहीं होगी और इसके लिए जे.सी.बी. का उपयोग नहीं किया जाएगा।
16. प्रयोक्ता एजेंसी किसी भी प्रकार के रख-रखाव के कार्यों के लिए वन विभाग के स्थानीय अधिकारी की अनुमति प्राप्त करेगी।
