Diversiòn of 9.08 ha. of forest land in favour of Executive Engineer, Provincial Division, PWD (B&R) Br, Faridabad for providing divided carriageway of 5.5 meter each on Ballabgarh-Chhainsa-Mohna road from km. 3 to 14.96. under forest division and District Faridabad, Haryana (Online proposal FP/HR/ ROAD/43612/2019)

The compliance of in principle approval is hereby submitted for your kind information and necessary action.


**(A) Conditions which need to be complied prior to handing over of forest land by the State Forest Department.**

- i) Cost of compensatory afforestation and Addl. Compensatory afforestation as per CA scheme has been deposited by us (copy of proof of payment done is attached).
- ii) Net Present Value (NPV) of the forest land being diverted for non-forestry purpose has been deposited , as per Ministry's directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
- iii) As per the orders of the Government of India vide letter No. 5-2/2010-CAMPA 24.06.2011, the Net Present Value (NPV) of the forest land and all other CA levies has been deposited through web portal of Ministry of Environment, Forest and Climate Change [www.parivesh.nic.in](http://www.parivesh.nic.in).
- iv) The compensatory levies (CA cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only.
- v) This point is related to forest department.
- vi) This point is related to forest department.
- vii) compliance of old proposals, FP/HR/Road/18898/2016 namely, (HRB101/2016) & FP/HR/Road/540/2007 (HRB536/2007) is being done by us and complete compliance will be submited soon.
- viii) Copy of FRA certificate received from District Colector, Faridabad is attached.

**(B) Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:**

- i) Legal status of the forest land will remain unchanged.
- ii) Efforts will be made to fell minimum number of trees and in any case, not more than 1,763 Trees and 1,093 plants.
- iii) The trees will be felled under strict supervision of the State Forest Department only.
- iv) This point is related to forest department.

- viii) The forest land will not be used for any other purpose than that mentioned in the proposal.
- ix) The forest land proposed to be diverted under no circumstances will be transferred to any other agency, department, or person without approval of the Central Government.
- x) The layout plan of the proposal will not be changed without the prior approval of the Central Government.
- xi) We will raise strip plantation on both sides and central verge of the road at the project cost as per IRC specifications with maintenance of seven to ten years.
- xii) No damage will be done to the adjoining forest land.
- xiii) No labour camp will be established on the forest land.
- xiv) We will pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court.
- xv) We will carry out muck disposal at pre-designated sites as per the scheme approved by the Forest Department. The required soil conservation measures will be taken up as per rules.
- xvi) We will provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- xvii) Any other condition that Regional Office may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife will be followed by us.
- xviii) It will be responsibility of our department to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal.

At last, it is requested to please issue final approval in this case at the earliest so that the necessary project work can be carried out.
