Please refer to the above cited subject and letters seeking prior approval of the Central Government for diversion of forest land for non-forestry purpose in accordance with section 2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the proposal of the State Government and recommendation of the REC, in-principle approval is hereby conveyed for diversion of 27.792 hectares of forest land for the above mentioned project, subject to the following conditions:
- A) Conditions which need to be complied prior to handing over of forest land by the State Forest Department.
 - i) Amended CA scheme with provisions of EPA, fencing, and modified species selection, etc be prepared & provided and accordingly Cost of compensatory afforestation as per scheme may be realized from the user agency.
 - ii) Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may be realized from the user agency, as per Ministry's directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
 - iii) As per the orders of the Government of India vide letter No. 5-2/2010-CAMPA 24.06.2011, the Net Present Value (NPV) of the forest land and all other CA levies

- shall be deposited through web portal of Ministry of Environment, Forest and Climate Change www.parivesh.nic.in.
- iv) User agency should ensure that the compensatory levies (CA cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
