होदय,

कृपया उपर्युक्त विषय से संदर्भांकित पत्र का अवलोकन करें जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा-2 के अधीन अनुमति मांगी गई है।

राज्य सरकार के प्रस्ताव का ध्यानपूर्वक अध्ययन करने के पश्चात उपर्युक्त विषय हेतु **0.94** हेक्टेयर वन भूमि के उपयोग के लिए सैद्धान्तिक स्वीकृति निम्नलिखित शर्तों को पूरी करने पर प्रदान की जाती है।

- i) वे शर्तें, जिनका राज्य वन विभाग द्वारा वन भूमि सौंपने से पहले अनुपालन करने की आवश्यकता है:-
 - i. प्रयोक्ता एजेंसी से CA स्कीम के अनुसार प्रतिपूर्ति पौधारोपण और अतिरिक्त प्रतिपूर्ति पौधारोपण की राशि जमा करवाई जाये।
 - ii. WP (C) No. 202/1995, IA No. 566 में माननीय उच्चतम न्यायालय के आदेश दिनांक 30.10.2002, 28.03.2008, 24.04.2008 एवं 09.05.2008 तथा पर्यावरण एवं वन मंत्रालय, भारत सरकार, नई दिल्ली के निर्देश संख्या 5-3/2011-FC(vol-I) दिनांक 06.01.2022 के अनुसार प्रयोक्ता एजेंसी से प्रस्तावित वन भूमि की नैट प्रजेंट वैल्यू जमा करवाई जाये।
 - iii. प्रयोक्ता एजेंसी भुगतान राशि पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय की वेबसाइट www.parivesh.nic.in पर केवल ऑनलाइन माध्यम से जमा करवाएगी।
 - iv. प्रयोक्ता एजेंसी को यह सुनिश्चित करना है कि प्रतिपूरक शुल्क (सीए लागत, एनपीवी, आदि) वेब पोर्टल पर ऑनलाइन उत्पन्न चालान के माध्यम से जमा किए जाते हैं और केवल उपयुक्त बैंक में जमा किए जाते हैं। अन्य माध्यम से जमा की गई राशि को S-I clearance के अनुपालन के रूप में स्वीकार नहीं किया जाएगा।
 - v. प्रयोक्ता एजेंसी यह सुनिश्चित करेगी कि Division में कोई अन्य प्रस्ताव, जिसके लिए S-I पहले ही स्वीकृत किया जा चुका है, S-I अनुमोदन की शर्तों के अनुपालन के लिए अभी भी लंबित नहीं है। इस आशय का एक वचन पत्र कि "इस Division के पास S-I अनुमोदन की शर्तों के अनुपालन के लिए ऐसा कोई प्रस्ताव लंबित नहीं है" प्रस्तुत किया जाए। इस कार्यालय द्वारा इस प्रस्ताव की अंतिम मंजूरी के लिए उसका अनुपालन अनिवार्य होगा।

- vi. इनमें से किसी भी शर्त का उल्लंघन वन (संरक्षण) अधिनियम, 1980 का उल्लंघन माना जाएगा और Handbook Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 (Guidelines & Clarification 2019, MoEF&CC के अध्याय 1 के पैरा 1.21 में निर्धारित अनुसार कार्रवाई की जाएगी।
- vii. जब तक प्रयोक्ता एजेंसी द्वारा S-I की शर्तों के अनुसार संपूर्ण शुल्क जमा नहीं किए जाते और मंत्रालय के वे पोर्टल पर ऑनलाइन पुष्टि नहीं की जाती, तब तक राज्य सरकार अस्थायी कार्य अनुमति जारी नहीं करेगा।
- viii. FRA प्रमाणपत्र की मूल प्रति अपलोड/प्रदान की जानी है।
- ix. सीए स्कीम में एनपीवी की राशि, पर्यावरण एवं वन मंत्रालय, भारत सरकार, नई दिल्ली के निर्देश संख्या 5-3/201 FC(vol-I) दिनांक 06.01.2022 से प्रभावी नई दर के अनुसार वसूल की जानी है।
- (B) वे शर्तें, जिनका राज्य वन विभाग द्वारा प्रयोक्ता एजेंसी को वन भूमि सौंपने के बाद फील्ड में कड़ाई से पाल करने की आवश्यकता है, परन्तु अंडरटेकिंग के रूप में अनुपालन स्टेज-II अनुमोदन से पहले प्रस्तुत किया जा है:-
- वन भूमि की विधिक परिस्थिति बदली नहीं जाएगी।
 - प्रस्ताव के अनुसार कम से कम वृक्ष काटे जायेंगे और वृक्षों की कटाई के दौरान वन्य जीवों को किसी तरह का नुकसान नहीं पहुंचाया जाएगा। प्रस्ताव के अनुसार काटे जाने वाले वृक्षों की संख्या 109 और पौधों की संख्या 195 से अधिक नहीं होगी।
 - सीए योजना के अनुसार प्रतिपूर्ति पौधारोपण व अतिरिक्त प्रतिपूर्ति पौधारोपण, 2270 पौधे (2.270 हेक्टेयर क्षेत्र में) Compartment No. Gurgaon Feder RD 30 to 55, जिला- फरीदाबाद में वन भूमि पर किया जाएगा और धन उपयोगकर्ता एजेंसी द्वारा प्रदान किया जाएगा। अनुमोदन जारी होने की तिथि से एक वर्ष के भीतर वृधारोपण किया जाएगा।
 - नवीनतम वन (संरक्षण) नियम 28.06.2022 के अनुसार, पांचवें वर्ष में न्यूनतम कैनोपी घनत्व कम से कम 0.4 होना चाहिए और परिपक्व वृधारोपण (mature plantation) में वनस्पति घनत्व कम से कम 0.7 होना चाहिए।
 - राज्य सरकार प्रयोक्ता एजेंसी को वन भूमि को गैर वानिकी कार्यों के लिए हस्तान्तरण से पूर्व स्वीकृत प्रतिपूर्ति पौधारोपण (CA) क्षेत्र की KML फाइल को भारतीय वन सर्वेक्षण (FSI) के E-Green Watch पोर्टल पर अपलोड करना सुनिश्चित करेगी।
 - वन भूमि का प्रयोग प्रस्ताव में दर्शाये गये उद्देश्य के अलावा किसी अन्य उद्देश्य के लिये नहीं किया जायेगा।
 - साथ लगते वन और वन भूमि को किसी तरह का कोई नुकसान नहीं पहुंचाया जायेगा और साथ लगते हुए वन और वन भूमि को बचाने के लिये सभी प्रयत्न किये जायेंगे।
 - जब कभी भी NPV की राशि बढ़ाई जायेगी तो उस बढ़ी हुई NPV की राशि को जमा करने के लिए प्रयोक्ता एजेंसी बाध्य होगी।
 - स्थानान्तरण के लिए प्रस्तावित वन भूमि को केंद्रीय सरकार की पूर्व अनुमति के बिना किसी भी परिस्थिति में किसी अन्य एजेंसी, विभाग या व्यक्ति विशेष को हस्तांतरित नहीं किया जायेगा।
 - केंद्रीय सरकार की अनुमति के बिना प्रस्ताव की ले आउट प्लान को बदला नहीं जायेगा।
 - वन भूमि पर किसी भी प्रकार का कोई श्रमिक शिविर नहीं लगाया जायेगा।
 - प्रस्तावित संचरण लाइन के लिए "रास्ते के अधिकार" की अधिकतम चौड़ाई वन भूमि पर 18 मीटर होगी।

- xiii. प्रत्येक कंडक्टर के नीचे टेंशन सटरिंगिंग उपकरण लगाने के लिए 3.0 मीटर की चौड़ी पट्टी में निकामी की अनुमति दी जायेगी | परन्तु सटरिंगिंग कार्य खत्म होने पर प्राकृतिक सम्पोषण होने दिया जायेगा |
- xiv. कंडक्टर तथा पेड़ों के बीच का फासला कम से कम 3.4 मीटर होना चाहिए | कंडक्टरों के झुकाव तथा झोल को ध्यान में रखा जायेगा | बिजली की निकासी बनाये रखने के लिये जब कभी आवश्यक होगा तो पेड़ों की काट छांट का कार्य स्थानीय वन मण्डल अधिकारी की अनुमति से किया जायेगा |
- xv. प्रयोक्ता एजेंसी जंगली जानवरों को बिजली के करंट से बचाने के लिए आवश्यक ग्राउंड क्लीयरेंस के अलावा उचित स्थानों पर सर्किट ब्रेकर स्थापित करेगी |
- xvi. प्रयोक्ता एजेंसी राज्य वन विभाग से विचार-विमर्श करके संचरण लाइन के नीचे मार्गाधिकार में छोटे कद के पौधों, मुख्य रूप से औषधिय पौधों के रोपण, सृजन व रख-रखाव की विस्तृत योजना तैयार करेगी तथा उक्त योजना के निष्पादन के लिए राज्य वन विभाग को धन राशि उपलब्ध करायेगी |
- xvii. प्रयोक्ता एजेंसी द्वारा श्रमिकों तथा कार्यस्थल पर कार्यरत स्टाफ को अधिमानतः वैकल्पिक इंधन उपलब्ध करायेगी, ताकि साथ लगते वन क्षेत्र को किसी प्रकार के नुकसान तथा दबाव से बचाया जा सके |
- xviii. यदि आवश्यक हो तो प्रयोक्ता एजेंसी पर्यावरण (सुरक्षा) अधिनियम 1980, के अनुसार पर्यावरण अनुमति प्राप्त करेगी |
- xix. कूड़ा कर्कट निपटान वन विभाग द्वारा जारी योजना के अनुसार किया जायेगा |
- xx. अन्य कोई भी शर्त इस क्षेत्रीय कार्यालय द्वारा वन तथा वन्य जीवों के संरक्षण, सुरक्षा तथा विकास हेतु समय - समय पर लगाई जा सकती है |
- xxi. यदि कोई अन्य सम्बंधित अधिनियम/अनुच्छेद/नियम/न्यायालय आदेश/अनुदेश आदि इस प्रस्ताव पर लागू होते हैं तो उनके अधीन जरूरी अनुमति लेना राज्य सरकार की जिम्मेवारी होगी |
4. उपरोक्त पैरा-2 के अधीन शर्तों की अनुपालना रिपोर्ट प्राप्त होने के उपरान्त वन संरक्षण अधिनियम, 1980 की धारा-2 के अधीन अन्तिम स्वीकृति के लिये प्रस्ताव पर विचार किया जायेगा। केन्द्रीय सरकार की अन्तिम अनुमति दिये जाने तक वन भूमि का उपयोग नहीं किया जायेगा।
