

1	The number of nuisance trees/plants to be cut shall not in any way exceed the number shown in the proposal and no harm shall be done to the wildlife during felling of trees.	NA
2	Compensatory afforestation shall be taken up by the Forest Department over degraded forest land in Thall, Compartment no. 25a/Blr, Range-Malhar, Billawar Forest Division District Kathua at the cost of the user agency. The plantation shall be done within one year from the date of issue of approval. As far as possible, a mixture of local indigenous species shall be planted and monoculture of nay species may be avoided.	NA
3	The Divisional Forest Officer shall furnish undertaking that the approved CA site (s) will not be changed without the approval of competent authority.	NA

6	The forest land shall not be used for any purpose other than that specified in the project proposal.	Agreed
7	The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court and the UT government will ensure that the increased amount is deposited.	Agreed
8	The permission will be given to this proposal for 99 years, after that permission shall be obtained from the Government of India. The period of diversion under this approval shall co-terminus with the period of lease to be granted in favor of the user agency or the project life, whichever is less.	Agreed
9	NO damage will be done to the adjoining forest land. Simultaneously , all efforts will be made to save adjoining forest and forest land.	Agreed
10	The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department, or person without approval of the Central Government.	Agreed

11	The layout plan of the proposal shall not be changed without prior approval of Central Government.	Agreed

In compliance with the Ministry of Environment and Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt) Dated:3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition) of Forest Rights) Act, 2006 (FRA,) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated:5<sup>th</sup> February 2013 wherein MoEF issued certain exemption/relaxation in respect of linear projects, it is certified that 1.505 hectares of forest land is proposed to be diverted in favour of **construction of road from Bani to Billawar Via Dhaggar, Dhaman and Deri Gala under CRS Phase-I** -, in District Kathua. Detail of the roads/projects is given below:

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire of 1.505 Hectares of forest area proposed for diversion. As per MoEF letter No. F.No. 11-9/98-FC (pt), Dated: 5<sup>th</sup> Feb. 2013 for linear projects like construction of roads, there is no requirement of resolution (meeting/consent) of Gram Sabha

of that area for forest land, use of which is proposed to be diverted. Hence, no such records of all consultations and meetings of the Forest Right Committee(s) Gram Sabha(s), Sub-Division Level Committee(s) and the District Level Committee are enclosed.

- (b) Additional Deputy Commissioner, Billawar vide office letter No. ADC/Blr/2023-24/2400-05 dated 14-09-2023 has reported that there is no pendency of any FRA claim in the Panchayat village Marhoon and Malad falling in the said project area.
- (c) Sub Divisional Magistrate, Bani vide office letter No. SDM/B/2023-24/407 dated 02-11-2023 has reported that no FRA claim is pending in Panchayat Dhaggar and Dhaman of Block Duggan Tehsil Bani.

Hence, Forest Rights Act certificate is issued for forest land measuring 1.505 Ha. required for Construction of road from Bani to Billawar Via Dhaggar, Dhaman and Deri Gala under CRS Phase-I, in District Kathua.


