

CONDITIONS OF IN. PRINCIPLE APPROVAL, ACCORDED BY FOREST, ENVIRONMENT
AND ECOLOGY DEPARTMENT UT OF JAMMU & KASHMIR

It is to state that the PWD(R&B) Division Ramnagar, UT of J&k, who is the Project Authority for the diversion of 0.58 ha forest land for non-forest use in the " Construction of the road khadwal to Bhatti Talab by way of earth work in cutting inclusive construction of kacha drain under State Plan" hereby agree on the below mentioned points as per the terms and conditions of Forest, Environment and Ecology Department, Government of Jammu and Kashmir. The points are:-

1. Efforts should be made to fell minimum number of trees, if applicable.
2. The KML files of the area to be diverted, area accepted for raising CA, proposed SMC works, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.
3. Compensatory afforestation will be carried out over Degraded Forest land (DFL) upon 1.20 ha of land on Comp No. 2/T Tehsil-Dansal, District-Jammu as per proposed CA scheme. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
4. The layout plan of the proposal shall not be changed without prior approval of Central Government.
5. The forest land shall not be used for any purpose other than that specified in the project proposal.
6. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of the Ministry of Environment, Forest and Climate Change.
7. No labour camp shall be established on the forest land.
8. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
9. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
10. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
11. The user agency shall pay additional amount of NPV as and when increased by the orders of the Hon'ble Supreme Court.
12. The User agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
13. The User Agency shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
14. The User Agency shall raise strip plantation on both sides and central verge of the road as per IRC norms.
15. Speed regulating signage will be erected along the road at regular intervals in the Forest areas.
16. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per law as per the MoEF&CC Guidelines F.No. 11-42/2017-FC Dt: 29.01.2018.
17. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
