





22. Any damage done to the forest by the User Agency or its contractors shall be charged from the User Agency @ 10 times as per the standard rate of 2018 issued vide the Government Order No: 10-FST of 2018 dated: 09.01.2018.

23. The forest land so allowed for use shall return to the Forest Department free of any encumbrances when it is no longer required by the User Agency.

24. The user agency shall ensure that mulba to be excavated with the construction of proposed road shall be dumped either at identified places within the forest land or shall arrange the dumping of mulba outside the forest area.

25. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in>).

26. The use of forest land will not be allowed till final approval is accorded.

In compliance with the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5<sup>th</sup> February 2013 wherein MoEF issued certain exemption/relaxation in respect of linear projects, it is certified that **0.651 hectares** of forest land is proposed to be diverted in favour of **Public Works Department Katra, required for the Construction of 160 meter double lane motorable bridge over nallah Jhajjar on Panthal Jhajjar road Km 1<sup>st</sup> from Jhajjar side (under CRF)**, in district Reasi.

**It is further certified that:**

(a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.651 hectares of forest area proposed for diversion. As per MoEF letter No.F. No. 11-9/98-FC(pt.), Dated: 5th Feb 2013 for linear projects like construction of roads, there is no requirement of resolution (meeting/consent) of Gram Sabha of that area for forest land, use of which is proposed to be diverted. Hence, no such records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) and the District Level Committee are enclosed.

(b) Divisional Forest Officer, Forest Division Reasi vide office No. DFO/RFD/2686-87 dated 02-12-2020 has communicated that **no recognized rights of Primitive Tribal Groups (PTG) and Pre-Agricultural Communities (PAC) shall be affected in diversion of forest land for non forest use for construction of above mentioned PWD project in PWD Division Katra.**


