6	The User Agency shall demarcate the lease area in the manner specified at the time of approval at its own cost.	Agreed.
7	The lessee shall not sub-lease, mortgage & hypothecate the forest area.	Agreed.
8	The leased out area should be used for the purpose for which it is granted. In case, the land is not used for stipulated purpose within two years or when it is no longer needed for the stipulated purpose, the area would stand resumed to the Forest Department .	Agreed and follow the condition
9	No change in land use plan on forest land shall be done except with prior approval of government of india under FC act 1980.	Agreed and follow the condition
10	The application for renewal of the lease in the prescribed form and manner shall be submitted at least six months prior to the expiry of forest lease. In case no renewal is sought, the Lessee shall hand over the lease.	Agreed and follow the condition
11	No residential or commercial building shall be permitted in the forest area proposed for diversion.	Agreed and follow the condition
12	All waste/ debris generated shall be scientifically disposed off outside the forest area	Agreed and follow the condition
13	Any 'damages to forest area because of implementation of the Project shall be compensated by the lessee. The extent of damages shall be assessed by the jurisdictional chief/Conservator /Deputy Conservator of Forests.	Agreed and follow the condition
14	The Lessee shall ensure that no avoidable harm is caused to the fauna and flora in and around the proposed area.	Agreed and follow the condition
15	In case, any violation of the provisions of the Karnataka Forest Act, 1963 & and Rules, 1969 or other relevant Acts/Rules is reported during the lease period, the lease will be liable for forfeiture under section 82 of Karnataka Forest Act, 1963. The Chief Conservator of Forests/ Deputy Conservator of Forests concerned are authorized to take necessary action in this regard. 19	User Agency need to fullfill all the conditions stipulated in the approval accorded by the member secretary, eco sensitive zone monitoring committee & Deputy conservated forests, wildlife division, Mysuru vide letter No. A2/ACT/GL-396/2021,Dated:28-03-2022.	Agreed.
20	Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of chapter 1 of the handbook of comprehensive guidelines of forest (conservation) Act, 1980 as issued by the ministry of environment, forest and climate change vide letter No.F.No.5-2/2017-FC,dated:28 <sup>th</sup> March 2019.	Agreed.
