I, The Assistant Engineer, Public Works Department, Bridges section, Kannur

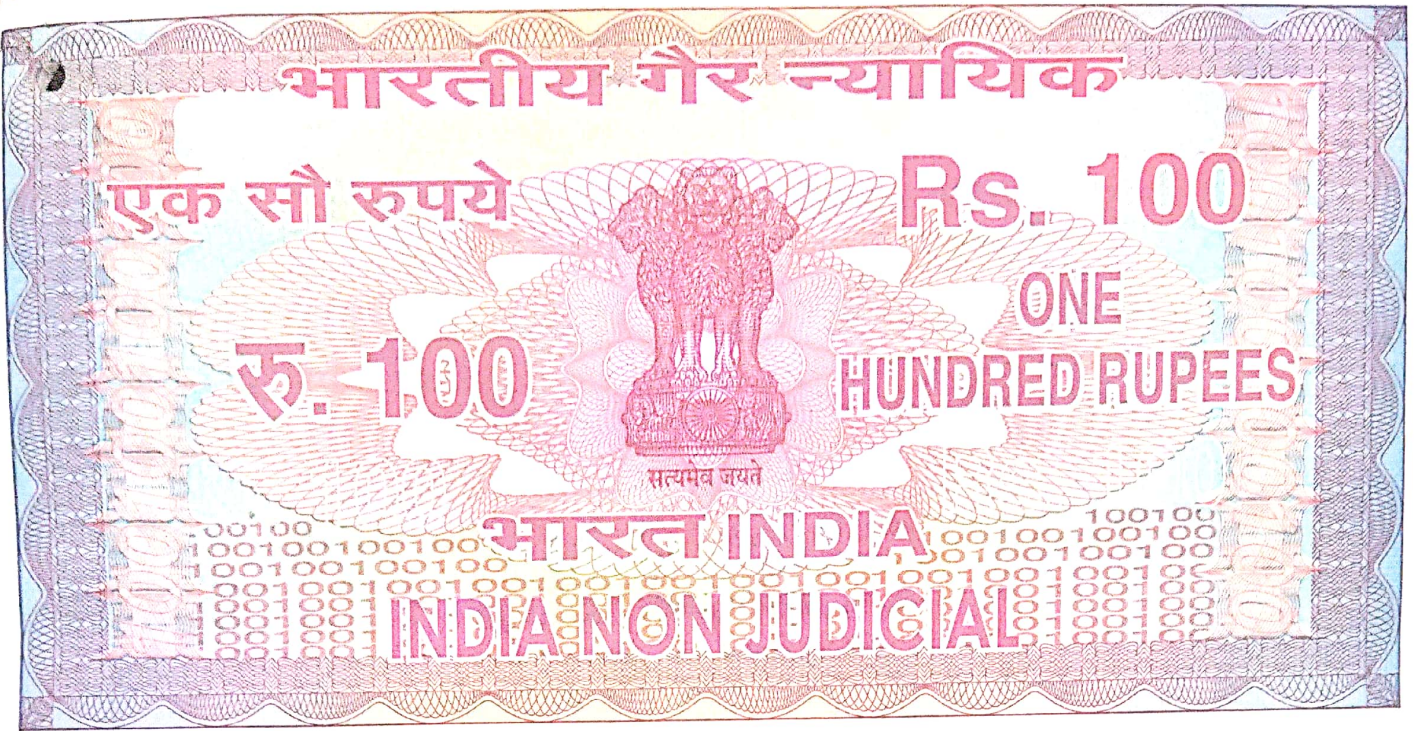
Hereby undertake to comply all the conditions (A) 1 to 9 and (B) 1 to 10 specified in the **Lr No F No 4-KLB1280/2021-BAN/654** Dated 21/09/2021 Ministry of Environment .Forest & Climate Change.

1. The User Agency shall transfer online, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02. 2009. The requisite funds shall be transferred through online portal into CAMPA account of the State Concerned.
2. The cost of raising plantation of ten times the number of trees to be felled shall be realised from the user agency.

3. The location of the area identified for raising the plantation shall be furnished before Stage-II clearance
4. All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (<http://parivesh.nic.in>). Amount deposited through other mode will not be accepted as compliance of the stage I clearance
5. The compliance report shall be uploaded on the E - portal (<https://parivesh.nic.in>)
6. The State Government shall complete the settlement of rights in terms of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest rights Act 2006 if any on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in its letter No 11-9/1998 FC dated 3 August 2009 read with 05 07 2013 with necessary enclosures in support thereof
7. The boundary of the diverted forest land shall be demarcated on ground at the project cost by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number distance from pillar to pillar and GPS co-ordinates

8. The KML file of the area proposed for diversion and degraded forest area identified for plantation in lieu of felling of trees shall be uploaded in the e-green watch portal with at requisite details
9. Violation of any of these conditions will amount to violation of Forest (Conservation) Act 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act 1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019:
10. Legal status of the forest land shall remain unchanged
11. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV if so determined, as per the final decision of the Hon'ble Supreme Court of India
12. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less
13. No labour camp shall be established on the forest land and the User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
14. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government
15. No damage to the flora and fauna of the adjoining area shall be caused.
16. The layout plan of the proposal shall not be changed without the prior approval of the Central Government.
17. The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.
18. The User Agency shall submit the annual self -compliance report in respect of the above stated conditions to the State Government and Integrated Regional Office, Bangalore by the end of March every year; and
19. The user agency shall comply all the provisions of the all Acts, Rules, Regulations Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project..
