Subject: Proposal for diversion of 17.263Ha of forest land for construction of Twin Tunnel Anakkampoyil Kalladi Meppadi Road in Kozhikode and Wayanad Districts of Kerala in favor of the Executive Engineer, PWD, Roads Division, Kozhikode. (Online Proposal No. FP/KL/ROAD/148616/2021)- Reg.

Vide ref. (1) compliance report of the stage-I approval dated 31.03.2023 w.r.t above subject proposal was forwarded by Forest & Wildlife (C) Department, Govt. of Kerala to R.O. Bangalore seeking final approval. In this regard after analyzing the compliance report four observations were raised by R.O. Bangalore vide ref. (2). Out of the four observations, FRA certificate has already been uploaded on the PARIVESH portal and remaining are in compiling stage and is being compiled by the State Forest department. In observation at Sr. no. (v) of ref. (2) survey image and sketch w.r.t the boundary demarcation was requested as per condition no. A (7) of the Stage-I approval letter dated 31.03.2023 which states demarcation of diverted forest land of 17.263 Ha on the ground.

In this regard vide ref. (3) it was appraised by the user agency to the officials of RO Bangalore that demarcation of diverted forest land for the subject proposal is not possible since the topography of the land is steep in nature and top of the hill is unapproachable and was also appraised that the diverted forest land is above the hill and will not be used by the user agency for any purpose since the construction of the tunnel is beneath the hill and the same was agreed by RO Bangalore.

Further, vide ref. (4) EDS raised on PARIVESH portal by Nodal Officer seeking the "Present Position on ground to be updated regarding with demarcation along with GPS Ids". In compliance to this GPS Ids of the diverted forest land in Kozhikode and Wayanad district which is unapproachable is earmarked in the attached Annexure A herewith. The following earmarked GPS Ids comprises forest land in Kozhikode and Wayanad District respectively:


