



9) The Forest area shall be used for the purpose for which it is granted. The total forest area utilized for this project shall not exceeded 0.0009 Ha.

10) The forest land proposal to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.

11) The compliance report shall be uploaded on e-portal. (http://parivesh.nic.in/).

12) Any other condition that the ministry of environment, forest and climate change may stipulate time to time in the interest of conservation, protection and development of forest and wild life.


