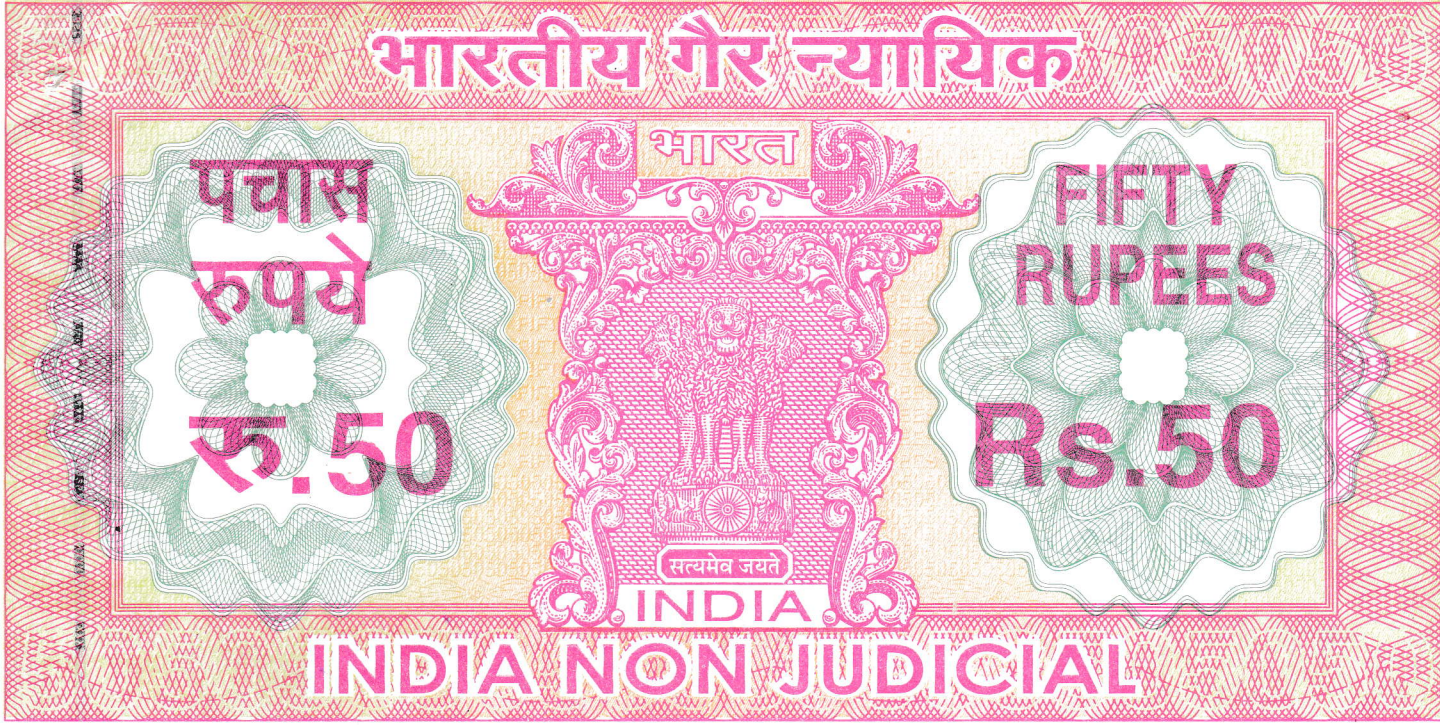



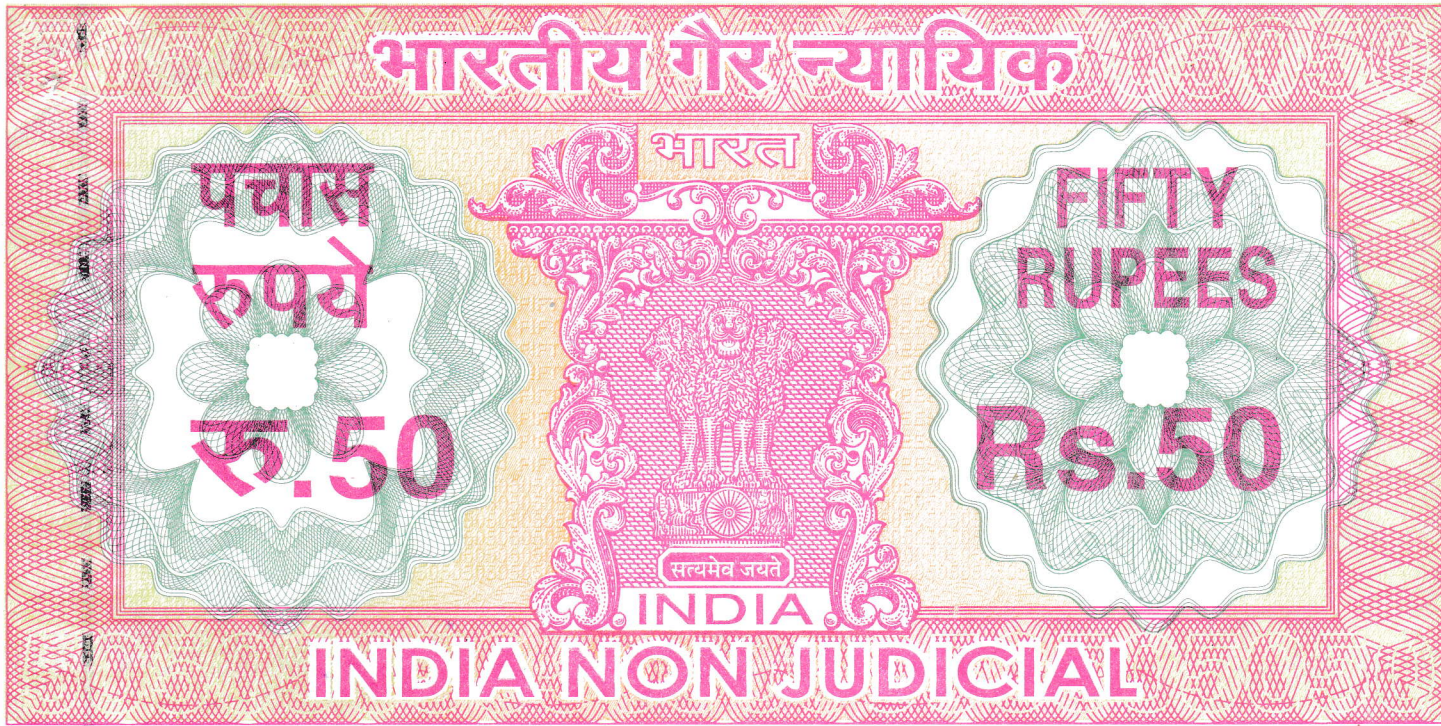

- 6) The layout plan of the proposal shall not be changed without prior approval of Central Government.

- 8) No additional or new path will be constructed inside the forest area for transportation of construction material for execution of the project work.
- 9) The Forest area shall be used for the purpose for which it is granted. The total forest area utilized for this project shall not exceed 0.0009 Ha.
- 10) The forest land proposal to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.
- 11) The compliance report shall be uploaded on e-portal. (<http://parivesh.nic.in/>).
- 12) Any other condition that the ministry of environment, forest and climate change may stipulate time to time in the interest of conservation, protection and development of forest and wild life.

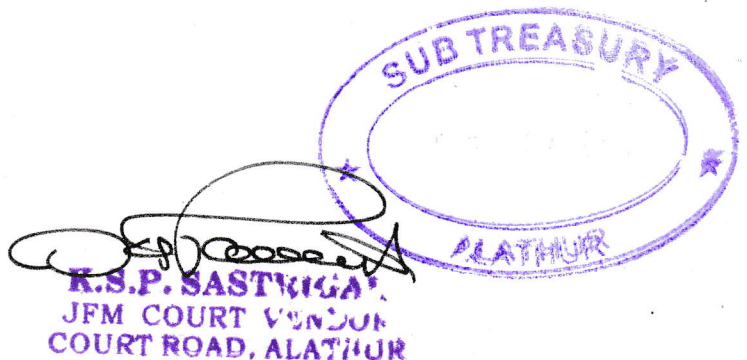
