Dear Sir/Madam,

With reference to the above subject proposal and letter, we had already submitted certificate under FRA, 2006 No. FRA/Certificate/ws-298/2018, Dated 24.05.2018 for the forest area of 0.1816 hectare received from District Collector, Palghar (Copy Enclosed). FRA certificate was not issued by the Collector, Palghar for the rest of the forest area mentioned as private land in the revenue records.

In this regard, we requested Collector, Palghar to issue FRA certificate for pending diversion area and he agreed to issue the same and he has issued FRA certificate for pending diversion area of 0.0411 dated 09.01.2024 which we submitting herewith. **Both the FRA certificate mentioned above for Diversion area of 0.1816 + 0.0411 = 0.2227 Hectare has been received from Collector, Palghar and enclosed herewith which we had already submitted vide this office letter mentioned ref. (3).**

To further state that the Collector, Palghar in his letter dated 09.01.2024 has informed that Survey No. 20 in pending FRA is old Survey No. and therefore they have issued FRA certificate for new Survey No. 149 of village Dehne which is correct. Copy of the letter is attached herewith.

Hope you will find above submission in order, we therefore request you to kindly take further necessary action for issuing Stage-II approval and do the needful at the earliest possible.

Since it is an Infrastructure development time bound project having nation importance and benefited the public at large, expeditious action is required for granting permissions, so that construction activity could be started at the earliest possible.


