Shree Satish Akode, Executive Engineer explained the Technical reasons for non feasibility of under pass which are as follows- <ul style="list-style-type: none"> i) A length of 240m Forest area starting from Ch.78/380 to 78/610 of NH 161E is located at Masola (Kh) village, Mangrulpir Tehsil in Washim District. This Forest area is laying between two sharp curves which is starts with Right hand curve and ends with Left

		<p>hand curve.</p> <p>ii) The entire area comes under the plain terrain.</p> <p>iii) If an underpass constructs below the finished road level, the invert level of under pass will be at least 4m below the original ground level. It will be buried in ground itself and it may lead to huge stagnation of water. As per the site conditions there is no stream/Way to discharge/drain out the water. This may lead inconvenience/danger to smaller size animals.</p> <p>iv) If an Underpass construction occurs over the finished road level, The geometrical design standards shall be followed as per IRC SP 23.</p> <p>(a) profile of the road shall be raised at least 4.50 m above the original ground level.</p> <p>(b) The design length of the vertical curve will be approximately 500 m i.e. at least 250m on either side of the underpass.</p> <p>(c) The location is comprising with horizontal curves and vertical curve in a short length.</p> <p>(d) As per table 2.7 of IRC SP 73, the Ruling Gradient shall be 2.5 percent and limiting gradient shall be 3.3 percent. The available length is not sufficient to design the vertical curve.</p> <p>(e) As per Clause 2.9.6 (v) of IRC SP 73, where the horizontal and summit curves overlap, the design shall be provided for the required sight distance, both in the vertical direction, along the pavement and in the horizontal direction on the inner side of the curve. As per Table 2.6 of IRC SP 73 and IRC SP 23, Safe sight distance shall be minimum 240m and over taking sight distance shall be 470 m. In this condition, the safe sight distance</p> <p>is not available in this area and may lead to the high-risk zone as well as accident-prone area.</p> <p>(f) As per IRC SP 73, Vertical alignment should provide for smooth longitudinal profile. Grade changes should not to cause kink and</p> <p>visual discontinues in the profile. 



The number and location of all such underpasses shall be finalized with consultation with State Forest Department. A compliance report on same shall be submitted to IRO, MOEF&CC, Nagpur along with compliance of Stage-1 approval;</p>	<p>At the time of submission of stage 1 proposal, under taking was given that the user agency ensures that construction of under passes for wild life passage with consultation of state forest department.</p> <p>At the time of road construction, after detailed survey, it was found that the construction of under pass for wild life was not feasible due to the topography of the site and technical reasons Road construction work in forest stretch of 240 Mtr. was completed after receiving working permission from forest department on date 03.08.2021. Now the work is completed.</p> <p>The joint inspection with forest department officers and MSRDC officers was done on dated 03.11.2022 and 16.02.2023 and it was clear from the site visit that, as per site condition it is not possible to construct under pass for wild life passage. Following observation are made during joint inspection.

1. Shree Anand Reddy Yellu (I.F.S), DCF, Washim inspected stretch/length of the forest area on Washim Dastapur Road (NH 161 E) of the project highway i.e., 240 meters.
 - a) It is observed that the work of project highway has been completed up to finish level in length of forest area after obtaining the working permission dated 03.08.2021.
 - b) At village Masola (Kh), Tehsil, Mangrulpir, Dist. Washim, GutNo.102 area 0.72Ha. forest land is located just adjacent to left side of ROW of project highway.
 - c) The underpass for Wild life passage with minimum dimension of 4 x 3 mts is not constructed.
2. It was explained by Shree Satish M Akode, Executive Engineer, MSRDC, Washim that they got conditional working permission on 03.08.2021 and before that there was numbers of fetal accidents happened in length passes in forest area and it was

demanding by Police, local administration politician and public for early completion of length in forest area to avoid frequent occurrence of human accidents. He further added one side of forest area is at nearly border and topography of the length in forest area is flat territorial and there is a turning on Washim side which may cause accidental spot. Hence it was not possible to construct an underpass.
