

- The User Agency shall implement animal passage plan prepared in consultation with Chief Wild Life Warden.
- 2. The User Agency shall bear the cost of mitigation measures which are suggested by the experts & shall contribute for restoration including: a. Minimum ground clearance of 11.60 m in the forest area, b. Vertical distance between two conductors should not be less than 3.9 meter for safe passage of avifauna.
- 3. Personnel, engaged in the project work shall abide the provisions of all the existing legal provisions, especially the Environment (Protection) Act, 1986, Wild Life (Protection) Act, 1972, Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and rules made there under & also take all precautionary measures for conservation & protection of flora, fauna in the vicinity of the project.
- The User Agency will make provision for barricading the work site to avoid any human or wildlife mishaps.
- No dumping of debris on wet lands and forest area will be done by User Agency.
 Any violation will be dealt in strictly.
- The laying of transmission line and its ancillary works should be carried out with utmost care so as to cause least impact on the wildlife in the notified protected area, & final ESZ.
- All the other mandatory permissions from different statutory authorities should be obtained prior to commencement of work.
- It shall be ensured that no damage or disturbance is caused to the wildlife and its habitat.
- 2% of the project cost for works within ESZ and Corridor should be deposited by
 the project agency with Tadoba-Andhari Tiger Conservation Foundation of
 Maharashtra for improvement of wildlife and its habitat in Wildlife Sanctuaries
 and National Parks in Maharashtra.
- 10. Insulated cables should be used along the entire stretch of the proposed transmission line passing through forest area in the tiger corridor so as to avoid electrocution to avifauna and other arboreal species as well as avoid poaching using electricity.

- 11. Width of the right of the way for the 132 kV DC transmission line on forest land should not be over 27 m (vide MoEFCC Guidelines F. No. 7-25/2012-FC dated May 5, 2014).
- 12. The trees required to be felled along the existing alignment shall be assessed correctly.
- 13. The alignment of the powerline should be made such that minimum numbers of trees are felled. Vegetation clearance along forest stretches should be avoided or minimized to the largest extent possible by increasing height of towers structure to maintain safe vertical clearance. Any felling/ pollarding/ pruning of trees for allowing electrical clearance/ maintenance will be done with the permission of competent authority of Maharashtra Forest Department. Only those trees that are of sufficient height to compromise the requirements of minimal vertical and horizontal clearance from the conductor wires at maximum sag point should be lopped.
- 14. Periodic clearing of vegetation along the powerline may bring up invasive species.

 Integrated vegetation management with the plantation of native, palatable species should be actively promoted by the User Agency in collaboration with Maharashtra Forest Department below the powerline. This will not only prevent growth of invasive unpalatable species like but also will provide excellent food for wild ungulates in form of its leaves and fruits.
- 15. No construction material (including soil, stones etc.) should be collected from the forest. Construction debris should not be dumped inside the forest or wetland areas and they should be transported by the User Agency to suitable dumping sites outside the forests and wetlands.
- 16. The right of way once it is cleared shall be divided in the following two zones:

A. Wire zone: The area below the powerline:

- i. Plant low-growing non-woody perennial and evergreen native plant species of herbs, grasses, and forbs.
- ii. Identify these plant species which have large flowers of cream colour, white colour, and bluish mauve, which are more preferred by pollinators.
- iii. Manage the area from encroachment by woody vegetation using manual removal of such species regularly.
- iv. A suggested tentative list of the plant species for this zone concerning the biogeographic zone may be considered. However, it is advisable to examine

the available checklists of regional flora or discuss plant taxonomist of that region for the selection of the required type of plant species for this zone.

B. Border zone: The area between the edges of the powerline and ROW:

- i. Select low-growing (dwarf) native perennial palatable shrub species having a maximum mature height of 3m and manage the area from encroachment by woody vegetation through manual removal.
- ii. Most of these are dwarf shrub species and may be selected from the suggested list in "Plantation Model for Planting Dwarf Species in RoW of Transmission Lines" (MoEFCC, 2023).
- 17. Management of vegetation beyond ROW edges as "Outer zone": This zone is beyond ROW, and it is less likely that any tree of mature height will touch the powerlines. Therefore, trees are permitted in this zone. It is suggested to plant suitable native trees in the right place to provide shade, cover, and wildlife habitat. Plantation of native palatable plant species may be selected from the "Plantation Model for Planting Dwarf Species in RoW of Transmission Lines" (MoEFCC, 2023) and upon consultations with Goa Forest Department.
- 18. The State Government shall take action for violation of Wild Life (Protection) Act, 1972 for the works carried out without the approval of the Standing Committee of the National Board for Wild Life.
- 19. CWLW, Maharashtra should develop appropriate mechanism to monitor the compliance of the conditions stipulated herein at various phases of project implementation.
- 20. An annual compliance certificate on the stipulated conditions shall be submitted by the User Agency to the State Chief Wild Life Warden and an annual compliance certificate shall be submitted by the State Chief Wild Life Warden to Government of India.



81.3 AMENDMENT IN THE MINUTES OF THE MEETINGS

81.3.1 Amendment in the minutes of the 79th meeting of the Standing Committee

Following three proposals for transmission lines by the Maharashtra State Electricity Corporation Limited were approved by the Standing Committee with certain conditions in the 79th meeting held on 31st July, 2024:

- a. 79.2.12 Proposal for use of 131.1255 ha (44.0937 ha forest land and 87.0858 ha non forestland) from tiger corridor connecting Tadoba Andheri Tiger Reserve and Indravati Tiger Reserve and tiger corridor land scape in between Tadoba Andheri Tiger Reserve and Tipeswar Wildlife Sanctuary and Kawal Tiger Reserve for the purpose of 132 KV DC Mul-SICOM Chandrapur Transmission line. WL/MH/TRANS/419749/2023
- b. 79.2.13 Proposal for use of 3.064 ha of forest land from the tiger corridor connecting Tadoba Andhari Tiger Reserve and Navegaon Nagzira Tiger Reserve for laying of 220 KV D/C Transmission Line from existing Umred Sub Station to proposed Nagbhid Sub Station Under MSETCL. FP/MH/TRANS/44469/2020
- c. 79.4.74 Proposal for use of 1.2005 ha of forest land & 29.484 ha of Non-forest land from Bor-Pench Tiger Corridor in Eastern Vidharba Landscape for laying of 220 KV Kalmeshwar to Warud EHV Transmission line in Nagpur district, Maharashtra. WL/MH/TRANS/450298/2023

The Standing Committee was informed that the present proposal is for amendment of one of the conditions imposed based on the advice given by the National Tiger Conservation Authority. The User Agency has requested to review the conditions that 'Insulated cables shall be used along the entire stretch of the proposed transmission line so as to avoid electrocution to avifauna and other arboreal species as well as avoid poaching using electricity.'

The User Agency through the State Forest Department, Maharashtra has informed that the lines are air insulated and have sufficient safety measures with respect to the wildlife/avifauna and have requested the stipulated condition.

The Ministry sought comments from the NTCA on the request made by the User Agency. The NTCA has concurred that the said condition may be reviewed subject to the condition that the User Agency will ensure use of best available technology for the project to prevent electrocution of avifauna and other arboreal species, as well as poaching of animals using electricity.

The Standing Committee was informed that the gap between the conductors acts as insulation. In case of such high voltage transmission lines, insulated cables are not technically feasible.

Dr. H. S. Singh suggested that the transmission line companies shall invest in research on installation of insulated cables of high voltage lines.

Decision Taken: After discussions, the Standing Committee decided that in the approvals given for these proposals, the condition that 'The User Agency shall ensure use of best available technology for the project to prevent electrocution of avifauna and other arboreal species, as well as poaching of animals using electricity' shall be substituted in place of the condition that 'Insulated cables shall be used along the entire stretch of the proposed transmission line so as to avoid electrocution to avifauna and other arboreal species as well as avoid poaching using electricity'.

81.3.2 Proposal for use of 24281 ha from Karakoram Wildlife Sanctuary for artillery firing and practice at Mandalthang field firing ranges (MTFFR), UT of Ladakh.

The Standing Committee was informed that the proposal from UT of Ladakh for use of 24281 ha of forest land from Karakoram Wildlife Sanctuary for artillery firing and practice at Mandalthang field firing ranges (MTFFR) was considered and recommended with certain conditions in the 73rd meeting of the Standing Committee of the National Board for Wild Life held on 17.07.2023.

One of the conditions imposed was that the User Agency shall pay Net Present Value (NPV) and other charges in accordance with the orders of the Hon'ble Supreme Court and the MoEF&CC guidelines.

The Army Hq. has requested for charging of NPV for Impact Zone of the
