In reference to the above cited subject, the central Government vide letter under ref (1) (copy enclosed) conveyed the "**In-Principle Approval**" for diversion of 22.045 ha of forest land for widening/improvement of existing road Chakpikarong - Sajik - Aigejang - Khongtal (0 KM to 19.5 KM) to NHSL Specifications in the state of Manipur by 84 RCC (GREF).

Further, the State Forest Department issued us a demand note for payment of NPV, CA cost, etc and for compliance of stipulated conditions given in IPA vide letter under ref (2,3) (copy enclosed) for stage II Clearance. The stipulated conditions and its compliance report is as under: -




